As a membership benefit insurance coverage is provided by, the Commercial General Liability Policy issued to USA Roller Sports. The policy will protect all members and clubs (in good standing) from claims made by negligent acts accidently committed resulting in bodily injury, personal and advertising injury or property damage to others.

How to Request a Certificate of Insurance

Should a club (in good standing) need a certificate of liability insurance, the USARS application Roller Sports Contest Insurance Application, must be filled out completely and submitted to the USARS National Office. A club may request a certificate for the membership season (referred to as a blanket certificate) if the facility is a USARS charter location or for a single event if the event is sanctioned by USARS. Applications are due 14 days prior to the event date. If there is a contract between the club and the venue, a complete and signed copy must be submitted with the application. Please note that the USARS membership season coordinates with the calendar year.
