# **Executive Director Search - Dan Whitley Process update**

**Vote: Passed unanimously** 

Close to 60 candidates applied. After consulting with the ExCom, the outside executive search facilitator conducted 15 phone screens, and using her recommendations, the ExCom narrowed the field to five. One withdrew. A group of Board members, the facilitator, and a former USAR executive director interviewed the four remaining candidates in person. Mike Wedel was extended the offer on 9/24/18 to assume the position of Executive Director of USA Racquetball. He notified Dan and the Board tonight of his acceptance.

### Staff and Related Topics - Dan Whitley

Renée Gundolff has been taking responsibility for covering many tasks in many categories. She has been instrumental to the stability of USAR in this time of transition. Dan asked the Board members to thank her individually as they see her in Minneapolis.

Tentative new office space (Copper Building/El Pomar) -- information was provided to the Board in a recent email. Benefits: savings of \$1,000/month in rent, large space to accommodate multiple staff members, workspace for interns, other NGBs are in the building. Mike will be addressing this as a priority.

3WallBall -- The IRT and John Scott will be providing streaming. Dan will be present in Las Vegas at the event.

## Fundraising Committee - Cindy Tilbury & Cheryl Kirk

Cindy described the grant application process that she has been facilitating on behalf of USA Racquetball. The grants are designed to gain funds to cover travel costs for the US Team in Chile and Costa Rica. There is no current timetable for submitting the applications.

Cheryl is compiling Board member profiles for the USAR website and also to satisfy the grant application requirement.
