# USA TABLE TENNIS ATHLETE SELECTION PROCEDURES 2020 Paralympic Games December 3, 2019

Amended February 4, 2021

#### 1. SELECTION SYSTEM

- 1. Provide the minimum eligibility requirements for an athlete to be considered for selection to the Team:
  - 1.1. Nationality/Passport requirements:
    - Athlete must be a national of the United States at the time of selection.
    - Athlete must hold a valid U.S. passport that will not expire for six months after the conclusion of the Games.
  - 1.2. Minimum Paralympic Committee (IPC) standards for participation:
    - Any competitor in the Paralympic, Parapan American Games must be a
      national of the country of the National Paralympic Committee (NPC) which is
      entering such competitor. For additional information regarding an athlete
      who is a national of two or more countries, has changed his or her nationality
      or acquired a new nationality, refer to the Olympic Charter (Rule 41), the IPC
      Handbook (Section 2, Chapter 3.1), or the Panam Sports
      Constitution (Article 30.5-6).
  - 1.3. Minimum International Federation (IF) standards for participation (if any):
    - Meet the requirements of the International Table Tennis Federation (ITTF) Tournament Credit System in effect for the qualification period (1 January 2019 to 31 March 2020). This does not apply to:
      - o Athletes qualified via the World Qualification Tournament, and
      - Athletes selected by the Bipartite Commission
    - Be ranked on the ITTF Para Table Tennis (PTT) World Ranking List closing 31
       March 2020;
    - Be internationally classified with a "Confirmed" sport class status or a 'Fixed Review Date' sport class status with a review date after 31 December 2021

Per the ITTF Tournament Credit System for Paralympic Qualification, athletes must meet both "A" and "B" criteria within the designated qualification period of 15 months:

- o A: All players must participate during the selection period as:
  - In their Regional tournament, OR
  - In one Fa40 tournament which will be held in a different continent
- o B: All players must participate in additional tournaments as:
  - Players from Oceania and Africa: in 1 more PTT tournaments
  - Players from America: in 2 more PTT tournaments
  - Players from Asia: in 3 more PTT tournaments
  - Players from Europe: in 4 more PTT tournaments.

- Have participated in at least one ITTF international sanctioned event between 1 January 2019 and 31 March 2020 for athletes qualified via the World Qualification Tournament.

#### 1.4. Other requirements (if any):

- Athletes must be members in good standing of USA Table Tennis (USATT) to be considered for the 2020 Paralympics Table Tennis Team. USA Table Tennis Membership must be valid through September 15, 2020 September 30, 2021.
- Athletes must have successfully completed all Games Registration requirements by stated deadlines.
- Athletes age 18 or older will be required to undergo a background screen in accordance with the current USOPC Background Check Policy.
- Athletes age 18 or older as of the Closing Ceremony date will be required to complete the U.S. Center for Safesport's online training.

#### 2. Tryout Events:

- 2.1. Provide the event names, dates and locations of all trials, events and camps to be used as part of the selection process.
  - a) 2019 ITTF PTT Regional Championships Allocation: 2019 Parapan American Games – August 20-28, 2019 in Lima, Peru. The male and female athlete that wins in each singles event at the 2019 Parapan American Games receives direct invitation from the ITTF Para Division to 2020 Paralympics.

Singles events at the 2019 ITTF PTT Regional Championships may include different sport class combinations from those at the Paralympic Games. In such cases, the Gold medal winner in the respective singles event will be allocated the 2019 ITTF PTT Regional Championships qualification slot for his/her respective sport class.

b) ITTF Para World Ranking List Allocation: The top ranked male and female athletes, not otherwise qualified, up to the established quota for the individual single event for the 2020 Paralympic Games based on off their ITTF Para World Ranking List Closing 31 March 2020 qualify. ITTF Para World Ranking points may be attained between January 1, 2019 through March 31, 2020:

c) World Qualification Tournament Allocation: The top finisher not otherwise qualified in each medal event will obtain one qualification slot.

In case a particular medal event is not offered at the Qualification Tournament, the respective slot will be allocated via the Bipartite Commission Invitation Allocation method. In case two or more classes are combined at the Qualification Tournament, the top ranked athlete in such a combined event obtains the qualification slot in their class while the vacant slots(s) will be allocated via the Bipartite Commission Invitation Allocation method.

In case the World Qualification Tournament cannot be organized, all slots will be allocated via the Bipartite Commission Invitation Allocation method.

d) Bipartite Commission Invitation Allocation: To be considered for a Bipartite slot, NPCs must submit an official application in writing to ITTF by 30 April 2020 February 15, 2021 April 9, 2021. IPC and ITTF will consider eligible male and female athletes for Bipartite Commission Invitation qualification slots up to the established quota for the individual singles event.

- e) Women's Team Events Completion Allocation: In order to secure viability of the Women's Team events four (4) female qualification slots will be allocated at the ITTF's discretion to eligible athletes who can complete a team together with another player from the same NPC. The selected athletes will also be allowed to enter their respective Singles event. If event viability has been secured the ITTF may chose not to allocate some or all of these slots.
- 2.2. Provide event names, dates, locations and description of how athletes qualify for the trials, events and camps listed above in 1.2.1.
  - a) 2019 Parapan American Games August 20-28, 2019 in Lima, Peru.
  - b) ITTF World Ranking.
    - a. Ranking points may be accumulated through participating in ITTF Para tournaments between January 1, 2019 and March 31, 2020 A list of eligible competitions can be found here: <a href="https://www.ittf.com/2019-para-table-tennis-calendar/">https://www.ittf.com/2019-para-table-tennis-calendar/</a> and <a href="https://www.ittf.com/2020-para-table-tennis-calendar/">https://www.ittf.com/2020-para-table-tennis-calendar/</a>
  - c) ITTF World Qualifying Tournament May 9 11, 2020 April 15-17, 2021 Lasko, Slovenia
- 3. Provide a comprehensive, step-by-step description of the method that explains how athletes will go through the selection process (include maximum Team size).
  - a) Qualification slots are allocated to the individual athlete, not to the NPC.

- b) An NPC may be allocated a maximum of three (3) qualification slots per individual medal event for a maximum of thirty-three (33) male slots and thirty (30) female slots.
- c) The qualification process to obtain individual male and female qualification slots can be found in the 2020 Paralympic Games Qualification Guide here and referenced in section 1.2.1: <a href="https://www.paralympic.org/sites/default/files/2021-02/2021-01-29%20Tokyo%20QG.pdf">https://www.paralympic.org/sites/default/files/2021-02/2021-01-29%20Tokyo%20QG.pdf</a>
- d) USATT may, but is not required to, submit an application for a bipartite slot depending on whether or not, as determined by the USATT Para High Performance Committee, there are athlete candidates who meet the discretionary criteria set forth in section 2. The USATT Para High Performance Committee shall be responsible for making any such selection and will disclose on its website (https://www.teamusa.org/usa-table-tennis/para/para-home) the submission of a particular athlete to the ITTF for a bipartite slot. USATT will accept any bipartite slots received.

#### 2. DISCRETIONARY SELECTION (if applicable)

2.1. Provide rationale for utilizing discretionary selection (if any):

The rationale for discretionary selection is to allow USATT the ability to nominate the best and top ranked athletes to the Tokyo 2020 Paralympic Games Team. Bipartite Invitations may result in appointment of athletes to the 2020 Paralympic Team up to the established quotas defined in in the Tokyo Qualification Guide: <a href="https://www.paralympic.org/sites/default/files/2021-02/2021\_01\_29%20Tokyo%20QG.pdf">https://www.paralympic.org/sites/default/files/2021-02/2021\_01\_29%20Tokyo%20QG.pdf</a>. To be considered for a Bipartite Commission Invitation, NPCs must submit an official application in writing to ITTF by April 30<sup>th</sup>, 2020 February 15, 2021.

2.2. List the discretionary criteria and explain how they will be used (if any):

From those non qualifying classes, the top athletes from the qualifying period of 2019 on the world ranking will also be considered, top of the country in that class, can also be nominated

2.2.1 Bipartite nominations will be considered as follows:

Criteria used to evaluate athletes for discretionary selections are as follows and are not listed in priority order:

• Only the top U.S. athlete in each class that does not have representation by the U.S. may be nominated. Athletes must also meet criteria set forth in Section 1.1.

- O Athletes had to have participated in at least one ITTF Para sanctioned event between January 1, 2019 and March 31, 2020.
- Athletes from the ITTF World Ranking list in 2020 and/or 2021 that have shown an ability to be competitive internationally
- Athlete has a world ranking no more than 10 spots below the total quota for each stated class
- Athlete is number 1 in their class in the Region
- The athlete(s) experienced equipment failure, weather, interference, or other external factors, either natural or caused by others, at the qualifying event(s), that impeded what otherwise likely would have been a qualifying result.
- The athlete demonstrates a trend of improving performance in international competition, that when extended a reasonable distance into the future, intersects the current international performance standards for a podium finish.
- The athlete, despite age or competing a relatively short time in the sport, has a performance trajectory that is favorable to future international success.

2.2.2. Further consideration for bipartite nominations will be given to athletes that can be a team event partner for an athlete that has already qualified for Tokyo 2020.

Priority for a team event partner will be given to athletes that have shown an ability to be competitive internationally with either a World Ranking no more than 15 spots below the total quota for each stated class or be ranked number one (1) in the class in the Region. In a case in which multiple athletes are being considered, the highest ranked player will be nominated and submitted for bipartite.

2.3 Provide the name of the committee that will be responsible for making discretionary selections, along with a complete list of the members' titles currently serving on the committee:

The USATT Para High Performance Committee:

- USATT Para HPC Chair
- Athlete Rep.
- Athlete Rep.
- USATT Para High Performance Committee Member
- Para High Performance Director (or interim)
- 2.3.1 Specify the process that will be used to identify and handle any potential conflicts of interest involving a member of the committee.

Any member of the selection committee that has a possible conflict of interest must disclose it. If such conflict exists, the selection committee member must recuse him/herself from committee discussions and voting. Further, the committee member should not otherwise influence other members of the committee in the selection process. However, a committee member who recused him/herself, but who has relevant and necessary information with respect to athlete performance, for example a national team coach or high performance director, may, if requested by the selection committee, provide such information to the committee so long as such information is provided in a fair and unbiased manner and the committee member who declared the conflict of interest does not vote toward the final decision.

#### 3. REMOVAL OF ATHLETES

3.1. Prior to entry by name to the Local Organizing Committee by the USOPC, USATT has jurisdiction over potential nominees.

An athlete who is to be nominated to the Team by USATT may be removed for any of the following reasons, as determined by USATT:

- 3.1.1. Voluntary withdrawal. Athlete must submit a written letter to the USATT CEO/Executive Director.
- 3.1.2. Injury or illness as certified by a physician (or medical staff) approved by USATT. If an athlete refuses verification of his/her illness or injury by a physician (or medical staff) approved by USATT, his/her injury will be assumed to be disabling and he/she may be removed.
- 3.1.3. Failure to participate in Mandatory Training and/or Competition as defined in Section 9 of these procedures.
- 3.1.4. Violation of the NGB's/HPMO's Code of Conduct (Attachment A).

- 3.1.5. Re-classification by the IPC/ITTF such that the athlete's qualifying performance would not have qualified him or her for the Team.
- 3.1.6. Removal by the IPC/ITTF of the event, in which the athlete qualified for the Team from the program of the 2020 Tokyo Paralympic Games.

An athlete who is removed from the Team pursuant to this provision has the right to a hearing per USATT's Bylaws (<a href="https://www.teamusa.org/USA-Table-Tennis/USATT/Bylaws">https://www.teamusa.org/USA-Table-Tennis/USATT/Bylaws</a>) and the USOPC's Bylaws, Section 9.

- 3.2. Once athlete entries have been submitted to the Local Organizing Committee by the USOPC, the USOPC has jurisdiction over the Team, at which time, in addition to any applicable USATT Code of Conduct, the USOPC's Code of Conduct and Grievance Procedures apply. - 3.3. An athlete may be removed as a nominee to the Team or from the Team for an adjudicated violation of IOC, Panam Sports, IPC, WADA, IF, USADA and/or USOPC anti-doping protocol, policies and procedures, as applicable.

#### 4. REPLACEMENT OF ATHLETES

- 4.1. Describe the selection and approval process for determining replacement athlete(s) should a vacancy occur:
  - 4.1.1. Prior to submission of Entries by Name to the Local Organizing Committee, including any applicable group or committee:

Reallocation of Unused Qualification Slots:

- Slots allocated at the 2019 ITTF PTT Regional Championships or the World Qualification Tournament:
  - Any qualification slots obtained through the individual qualification method at a 2019 ITTF PTT Regional Championships or at the World Qualification Tournament and not used by the respective NPC will be reallocated to the next highest ranked athlete(s) from that respective competition (not otherwise qualified). In the case that no eligible athlete is available, the slot(s) will be reallocated to the next highest ranked athlete(s) on the ITTF PTT World Ranking List closing 31 March 2020.
- Slots allocated through the ITTF PTT World Ranking List Allocation Method:

- Any qualification slots that are not used by an NPC will be reallocated by the ITTF to the next highest ranked athlete on the ITTF PTT Male and Female World Ranking Lists closing 31 March 2020.
- 4.1.2. After submission of Entries by Name to the Local Organizing Committee, including any applicable group or committee:

ITTF will reallocate.

#### 5. SUPPORTING DOCUMENTS

USATT will retain the approved Selection Procedures and all supporting documents, including scouting or evaluation forms, etc., and data from the selection process for six months past the date of the Closing Ceremony of the Games.

#### 6. REQUIRED DOCUMENTS

In addition to the USOPC Code of Conduct, the following documents are required to be signed by an athlete as a condition of nomination to the Paralympic Games and are included as attachments:

#### 7. PUBLICITY/DISTRIBUTION OF PROCEDURES

The USOPC approved Selection Procedures (complete and unaltered) will be posted/published by the USATT in the following locations:

These procedures will be posted as soon as possible, but not more than five business days following notice of approval by the USOPC.

#### 8. DATE OF NOMINATION

The Nomination of Athletes form, including replacements, will be announced to all athletes and submitted to the USOPC on or before: May 15, 2020 May 11, 2021

#### 13. INTERNATIONAL DISCLAIMER

These procedures are based on IOC, IPC, Panam Sports, as applicable, and/or ITTF rules and regulations as presently known and understood. Any change in the selection procedures caused by a change in IOC, IPC, Panam Sports, as applicable, and/or ITTF rules and regulations will be distributed to the affected athletes immediately. The selection criteria are based on the latest information available to USATT. However, the selections are always subject to unforeseen, intervening circumstances, and realistically may not have accounted for every possible contingency.

If any force of nature, or force majeure, should cause the altercation or cancellation of any of the selection events listed in this document, these selection procedures will be revised, pursuant to their resubmission to the USOPC.

#### 14. ATHLETE OMBUDSMAN

The Athlete Ombudsman provides cost-free, independent and confidential advice regarding athlete rights, grievance procedures and any other related guidance pertaining to selection procedures and can assist in mediating disputes between athletes and the ACA.



## USA Table Tennis Para National Team 2021 Code of Conduct

#### ATHLETE PLEDGE

I pledge to uphold the **USA Table Tennis Para National Team** Code of Conduct (the "Code") as a guide to my conduct while representing the United States of America and/or USA Table Tennis ("USATT"), both domestically and internationally in 2021.

I acknowledge that I have a right to notice and a hearing prior to being declared ineligible, if my opportunity to compete is denied, or if I am charged with a violation of this Code. I further acknowledge that if I am found to be in violation of this Code, I may be subject to sanctions up to and including suspension or dismissal from the Para National Team and USATT.

I am aware of the USATT complaint procedure established by the USATT Bylaws.

I have familiarized myself with the Code and understand that acceptance of its provisions is a condition of my selection to represent USA Table Tennis in 2021.

### IN ORDER TO BECOME A MEMBER OF THE PARA NATIONAL TEAM, AN INDIVIDUAL MUST SIGN THIS CODE OF CONDUCT IN UNALTERED FORM IN ALL APPLICABLE PLACES.

#### As a Member of the Para National Team, I hereby promise and agree that I:

- Will abide by all rules related to the Para National Team selection procedures as approved by the Para National Team and USA Table Tennis;
- Have acted and will act in a sportsmanlike manner consistent with the spirit of fair play and responsible conduct;
- Will maintain a level of fitness and competitive readiness that will permit my performance to be at the maximum of my abilities;

- Am eligible to compete under the rules of International Table Tennis Federation;
- Will have a valid USA passport for the duration of the time and six months after I am a member of the Para National Team.
- Will refrain from conduct detracting from my ability or that of my teammates to attain peak performance;
- Will respect the property of others whether personal or public;
- Will respect USATT Staff, Board of Directors, Committee Members and Volunteers, members of the Para National Team Coaching Staff, USATT-Designated Coaches, other Para National Team Members, opposing teams, spectators and officials, and engage in no form of discriminatory behavior or verbal, physical or sexual harassment or abuse;
- Will follow the Para National Team's rules and programs, including by way of example: rules regarding curfew, training, required attendance at team meetings, training and competition programs;
- Will play whenever I am selected and will not default or refuse to play when asked by the coach. I
  understand that if I refuse to play other than for reasons of illness, injury or other extenuating
  circumstances, I may be liable for sanctions up to and including dismissal from the Team and/or
  suspension of my USATT membership.
- Will accept the help, assistance, guidance, and support of members of the Para National Team Coaching Staff and/or coaches designated by the USATT High Performance Director for all matches in which I am representing the United States of America and/or USATT. If necessary, I also agree to play without a coach and/or to permit a teammate on the US Para National Team to serve as my coach in such competition. I further agree to assist my teammates on the US Para National Team when necessary to serve as their coach. I further understand that all other persons seeking to serve as my coach when I am representing the United States of America, USATT, and/or the US Para National Team must receive advance written approval from the USATT High Performance Director and the USATT Chief Executive Officer and be fully SafeSport Compliant to serve in such capacity.
- Will respect the needs of the US Para National Team at competitions and events and will assist the Para National Team Coaching Staff when requested, including providing assistance where

possible to my teammates on the Para National Team in competition-related activities such as warm-up play.

- Am aware that USA Table Tennis sponsors, suppliers and licensees provide critical support for the Para National Team and, in recognition of this fact, I will wear designated Para National Team and/or USA Table Tennis apparel at all official Team functions and events in which participation in the event, or related events, is funded (in full or partially) by USATT;
- Will not conceal or cover-up any USA Table Tennis sponsor, supplier or licensee brand or other identification appearing on my USA Table Tennis apparel;
- Agree to be filmed and photographed by the official photographer(s) and network(s) of USA Table Tennis and give event organizers and USA Table Tennis the right to use my name, picture, likeness, and biographical information before, during and after the period of my participation in these activities to promote the activity in which I participate or to promote the success of the Team on which I compete; in no event may USA Table Tennis or the event organizers use or authorize the use of my name, picture, likeness, voice and biographical information for the purpose of trade, including any use in a manner that would imply an endorsement of any company, product, or service, without my written permission;
