

# RESOLUTION #014 DECEMBER 26, 2023

By means of which the PAN AMERICAN RINK HOCKEY NATIONS CHAMPIONSHIP 2024 is announced and regulated in the categories SUB 19 MEN, SUB 19 LADIES, SENIOR MEN AND SENIOR LADIES, to be held in the city of Bogotá, from March 4 to 10, 2024.

The President of World Skate America WSA, in use of his legal and statutory authority;

## **CONSIDERING**

That World Skate regulated and announced that the teams and nations that are going to participate in the World Hockey Championship of the World Skate Games 2024, must be endorsed and classified through their participation and results in the corresponding continental championship, in this case the PAN AMERICAN RINK HOCKEY NATIONS CHAMPIONSHIP 2024, a rule that applies to the UNDER 19 MEN, SENIOR MEN AND SENIOR LADIES categories.

That World Skate America and its Rink Hockey Technical Commission, after analyzing the processes of women's hockey - training, sports population, projection in international competitions, etc. - has decided to call the U19 LADIES category to the PAN AMERICAN RINK HOCKEY NATIONS CHAMPIONSHIP 2024.

That it is the duty of World Skate America to regulate all events on the official calendar of all disciplines of skating on the wheels.

## **SOLVE**

**ART. 1st. ANNOUNCEMENT**. - Call and regulate, as is actually done, PAN AMERICAN RINK HOCKEY NATIONS CHAMPIONSHIP 2024 in the categories SUB 19 MEN, SUB 19 LADIES, SENIOR MEN AND SENIOR LADIES RINK HOCKEY, to be held in the city of Bogotá, from the 4th to the 10th. March 2024.



**PARAGRAPH 1. – CATEGORIES**: The PAN AMERICAN RINK HOCKEY NATIONS CHAMPIONSHIP 2024 will be held in the following categories and as follows:

#### **FEMALE BRANCH CATEGORIES**

**SUB 19 LADIES**: Female athletes who are at least 14 years old on the first day of the championship and who do not turn 19 years old until December 31, 2024.

**SENIOR LADIES**: Female athletes who are at least 14 years old on the first day of the championship and older.

### **MALE BRANCH CATEGORIES**

**MEN'S SUB 19:** Male athletes who are at least 14 years old on the first day of the championship and who do not turn 19 years old until December 31, 2024.

**SENIOR MEN:** Male athletes who are at least 14 years old on the first day of the championship and older.

This event will be competed in accordance with the technical regulations contemplated in the regulations published on the website <a href="http://www.worldskateamerica.org">http://www.worldskateamerica.org</a>

**ART. 2nd. CITY AND DATES** – The PAN AMERICAN RINK HOCKEY NATIONS CHAMPIONSHIP 2024 in the categories SUB 19 MEN, SUB 19 LADIES, SENIOR MEN AND SENIOR LADIES, will be held in the city of Bogotá, from March 4 to 10, 2024.

**ART. 3rd. ORGANIZATION**. - The Colombian Skating Federation will lead the organization of the event in administrative and logistical aspects, and may delegate it to one of its affiliated organizations; and the Rink Hockey Technical Committee of the WORLD SKATE AMERICA the sports technical aspects.

**ART. 4th. PARTICIPANTS.** - The different National Men's and Women's Rink Hockey Teams of the nations affiliated with WORLD SKATE that are part of the American continent may participate in this national championship, with the endorsement of their respective national federation.



**PARAGRAPH 1. NATIONAL PLAYERS**: All players of the PAN AMERICAN RINK HOCKEY NATIONS CHAMPIONSHIP 2024 in the categories SUB 19 MEN, SUB 19 LADIES, SENIOR MEN AND SENIOR LADIES, must prove the nationality of the country they represent through the respective Passport and through their respective delegates.

**ART. 5º.- REGISTRATIONS**. – For the Nations event, each country may be present with a single team in each of the categories and branches of the championship.

Registrations will ONLY be received on the official WORLD SKATE AMERICA form for Rink Hockey championships. This form must be completed completely (names, jersey numbers, date of birth, card number or license of each federation) on a computer and sent via e-mail only by the Federations to the email address <a href="mailto:cthp@wordlskateamerica.org">cthp@wordlskateamerica.org</a>

ORDINARY registrations will be received until January 26, 2024 and EXTRAORDINARY until February 2, 2024.

The registration fee for each team are those stipulated by WORLD SKATE AMERICA in its rate bulletin as follows and always in US dollars:

The registration fee will be paid in cash at the facilities provided by WORLD SKATE AMERICA for accreditation and information meeting.

**ART. 6th.- AWARD.** The WORLD SKATE AMERICA will have the following awards for the Championship, which will be delivered at its end:

- To the Pan American Champion, a Trophy plus 16 Gold Medals.
- To the Pan American Sub-Champion, 16 Silver medals.
- Third Pan American Place, 16 Bronze medals.



ART. 7th - PROTESTS AND CLAIMS. - Any protest or claim must be presented in the first instance in writing by the respective delegate of the complaining team, complying with the provisions of the WORLD SKATE modality regulations, and particularly for this event up to a maximum of one hour after the end of the match. object of the claim, the protest must be signed by the delegate of the team/federation who is duly accredited and accompanied by US\$ 350 to the members of the championship's Sports Court.

If the result is adverse to the claimant, he or she may file an appeal or protest before the technical committee of the WORLD SKATE AMERICA (maximum one hour after the ruling is issued by the judges) signed by the delegate of the team/federation who is duly present, accredited and accompanied by US 600.

Each amount must be deposited to the World Skate America delegate in charge of the championship; In the event that a ruling is pronounced in favor of the claimant, that amount will be returned to him/her; Otherwise, it will be credited to the World Skate America account within 48 hours following the end of the event.

## **ART. 8º - EVENT AUTHORITIES.**

- The highest authority of the event is the Delegates of the WORLD SKATE AMERICA Technical Commission:
- Mr. Daniel Martinazo, President CTHP-WSA Argentina.
- Mr. Ricardo Suárez, CTHP-WSA Member Colombia
- Mr. Brent Sisson, CTHP-WSA Member USA
  - The highest judging authority will be the member of the Technical Committee or the International Referee designated as coordinator of judges for the event, and who is designated by the president of WORLD SKATE AMERICA.
  - The highest disciplinary authority will be the Disciplinary Court of the event. Which will be
    made up of a member of the WORLD SKATE AMERICA Technical Committee, the designated
    referee coordinator (whether this is an international referee or a member of the Technical
    Committee) and a representative designated by the Federation Hosting the event.
  - The highest administrative authority will be the Steering Committee of the event, headed by the President of WORLD SKATE AMERICA.

**ART. 9° - ARBITRATION APPOINTMENT.** The referees for the PAN AMERICAN RINK HOCKEY NATIONS CHAMPIONSHIP 2024 will be appointed by the CTHP-WSA, must be of the "International Category" and be up to date with their World Skate fees.



**ART. 10° - ADMINISTRATIVE OBLIGATIONS.** – The administrative and financial obligations for the development of the event will be agreed between the President of the WORLD SKATE AMERICA and the president of the host Federation, in such a way that all services are guaranteed, and an adequate organization of the event in technical aspects, logistics, judging, safety and health for participants, the media and spectators.

**PARAGRAPH.** Only the WORLD SKATE AMERICA Rink Hockey Technical Committee may modify match schedules, for the general benefit of the development of the event.

**ART. 11°- INFORMATIONAL MEETING**. - The information meeting of the event will be held at the place and time that the event organization provides for this purpose and which will be announced in the official invitation. For this meeting, the presence of all delegates who are registered on the respective forms is requested.

ART. 12º RESPONSIBILITY IN ACCIDENTS. - The WORLD SKATE AMERICA and the COLOMBIAN SKATING FEDERATION are not responsible for accidents that may occur during the event, which is why all athletes and members of the coaching staff must have and prove valid medical and/or accident insurance, which in the case of countries foreign to Colombia, must be International Assistance that includes coverage of sports issues, ORIGINAL documents that must be presented at the time of the respective accreditations.

**ART. 13TH VALIDITY.** - This resolution is effective from the date of its issue. Given in the city of Bogotá, on the twenty-second (22nd) day of December 2023.
