Executive Committee Update – Stewart Solomon

The Executive Committee met on April 18, 2025. Topics discussed:

- Scorecard Stewart re-socialized this as a tool to guide and track strategic planning initiatives.
- Karen Grisz and Cheryl Kirk sent a letter to Debra Peters on 4/15/25 to update the Peters Family on the Manilla Athletics collaboration and kickoff of the Racquetball Coordinator Program.

US OPEN oversight - a new event logo was presented to the Board.

National Indoor Discussion – Stewart Solomon/OED

Stewart Solomon and Steve Czarnecki will vacate their Board seats at the adjournment of the May Annual Board meeting regular session since each have served six consecutive years on the Board.

Officer Elections – The President and Treasurer elections will take place at the reconvened meeting of the new Board after the regular session has adjourned.

A Board Roles & Responsibilities pre-read document was presented that included the process by which the elections will be administrated.

- USOPC/SafeSport compliance deadlines were met (before April 30) that included reports on Equal Pay for Athletes and State Reporting.
- IRT/USAR Streaming Agreement was executed by both parties.
- A SafeSport audit was conducted in St. Louis in April at the 2025 Missouri State Singles & Doubles Championships and seemed to go well. Results are pending.

- The OED and the U.S. Handball Association met on April 17. Topics discussed included the Manilla Athletics Racquetball Program Coordinator initiative; U.S. Handball National Center in Hazelwood, MO, with multiple courts (grand opening 5/27/25); etc.
- State Director Outreach Letter (Cindy Tilbury, Jonathan Greenberg, Cheryl Kirk); working on updating the distribution list; letter going out week of 4/28.

- PARC fundraising campaign provided support for sending a physical therapist to PARC as well as providing athlete entry fees and athlete stipends.

U.S. Team Committee – Cheryl Kirk

Junior Team Head Coach Recommendation

Motion by Sandy Rios to approve the recommendation of the U.S. Team Committee to name Robert Collins to the position of U.S. Junior Racquetball Team Head Coach effective June 1, 2025, through December 31, 2025, with stipulations that the Head Coach will not be able to privately coach athletes competing in Junior Team Qualifying divisions and that the Head Coach will participate in and support USA Racquetball's U.S. Junior Team fundraising strategy.

Seconded by Karen Grisz

Discussion: An athlete representative shared how another country selects their coaches by the number of players they work with. Question posed: Did we open any applications (i.e., was there a post for the position)? Answer: Not enough time to take applications with a number of other priorities facing the committee. ExCom discussed setting a timeline next year for when applications could be solicited.

Vote: Passed

World Games 2025 – Chengdu, China

USA Racquetball was compelled with a tight turnaround to submit a great deal of information from athletes (including passport scans and photos) in order to be able to include their names on the Late Athlete Replacement Period list (National Indoor results determines final decision). Most athletes were more than gracious and submitted their information quickly. The original athlete list was 24: 12 men/12 women. The final number submitted to the IRF Monday, April 21, was 8 men/8 women plus Head Coach Pablo Fajre.
