Venue: Table Tennis Connections, Boys & Girls Club of Larimer County, 1608 Lancer Drive, Fort Collins, Colorado 80521

Dates: 1/18/2025 – 1/20/2025

Equipment: 12 Butterfly Tables, Nets, Barriers, and Joola Prime 40+ 3-star Balls (white). The floor is a rubberized sports floor.

Rules: Players must be members of the USATT or other ITTF affiliated associations. The Laws of Table Tennis as published by the ITTF, and all USATT regulations apply. The USATT dress code will be observed. All matches will be best of 5 games to 11 points, except for the final of the Giant RR Division A and for the final of the Open, which will be best of 7.

Proof of membership: Every participant must show proof of USATT membership for all events. Membership and renewals will be sold at the event. Tournament pass \$50 / 1yr Basic \$25, 1 yr Pro \$75

Policies: The maximum number of players in any single event is twenty-four (24), except for the giant round robin where the maximum will be sixty (60) and doubles events where the maximum number of pairs will be sixteen (16). Events with insufficient entries may be canceled, and fees refunded. Unrated players will not be allowed to advance out of groups, except in the U500 and U750. The Tournament Director may assign an estimated rating to an unrated player. Only enter one event per start time.

Payment: Payments must be received prior to the start of the tournament, by Zelle (milehightta@gmail.com), by cash or by check (payable to Mile High Table Tennis Academy) and will not be accepted at the tournament. Payment for the registration must be made within three days of your entry, otherwise you may be removed to free up a slot for another player.

Entry Deadline: Only online entry will be available through www.omnipong.com, until Monday, January 13th, 2025 at the latest. Late entries may be accepted at the discretion of the tournament committee if an event is not full. A late fee of \$15 will apply.

Registration: Players must register with tournament officials at least 30 minutes before their first match and be ready to play each match 10 minutes before the scheduled starting time.

Withdrawal: Any player who wishes to withdraw from the event must do so by Monday, January 13th, 2025 at the latest. There will be no refunds after this date.

Ratings: Your rating on December 28th 2024 will be used for event qualifying. Seedings will be based on the most current rating available.

Playing System for Saturday's Giant RR Event:

9am: In a full event, group play will start with 12 RR groups of 5 players (max 60 players), with all players advancing to the next round. All first-place finishers go to Division A, all second-place finishers go to Division B, all third-place finishers go to Division C, all fourth-place finishers go to Division D and all fifth-place finishers go to Division E

1pm: Divisional Play, a second RR with 2 groups of 6 (12 players) per division, with 5 divisions total. The first and second-place finishers in each RR will advance to the SE playoff round.

6pm: Division Semifinals

6.30pm: Division Finals

Further Information

Round Robin groups will as much as possible consist of 4 players, with two players advancing to the single elimination draw.

No prizes will be awarded for splits, dumps, default losses or no-shows.

Children under 18 need to be accompanied by an adult/guardian or make alternate arrangements with TD. Tournaments can end early.
