RJ Committee Update

- The RJ Committee has been working with Enrique Orci in updating the supervisor's report. With that, a new version is available. Please contact Lydia Razo (lydiarazo@rocketmail.com) or Shawn Reese (shawnreese77@yahoo.com) for the updated version.
- Currently, monthly COO meeting attendance averages 60%. Shawn asked LBC leaders to encourage their COO to attend these meetings, to help meet the goal of 100%.
- The revised RJ Manual and Consolidated manual should be available by the end of January.
- We continued to encourage LBC leadership to send as many officials to nationals as possible. This is a great opportunity to work at the highest level in the country, while bringing back information learned, improving our LBCs.

Participant Questions

1. What is the process to dispute the result/outcome of a bout?

USA Boxing does not overturn decisions. However, if there are suspicions a procedural error occurred, which impacted the outcome of the bout, it can be reviewed. Any such concerns should be directed to Mike Campbell, <u>mcampbell@usaboxing.org</u>. From there, it will be sent to the appropriate parties for review. The submitter will be contacted with the outcome of the review and what further steps need to be taken.

2. Does USA Boxing vote on venues for upcoming national events?

We explained a few of the factors that go into choosing venues for national events. However, we deferred specific questions and a better understand of the process to Mike Campbell.

3. Per Appendix F, the Elite Male 187lb. category shows a 10 lb weight differential, while the proceeding and preceding weight category show 15 lbs. Is that a typo?

Yes, that is a typo, and we will work to get it corrected.

4. Our LBC has a trailer that we use to transport our ring. However, the trailer belongs to the LBC, and not an individual. Thus, it's making this hard to insure. Does anyone have advice.

We recommended speaking with a broker to help shop an appropriate business policy that will insure the
