## **I. Approval of AAC Meeting Minutes**

#### II. Chair Report

On March 9, C.Fu and D.Turgeon received questions about youth poomsae divisions. C.Fu talked with C.Simmons and the schedules for upcoming GP Regionals have been updated to include these new divisions.

Re: Cadet/Junior Pan Am Championships. D.Turgeon was involved from the beginning about the concerns and it's resolved as of now. There was a question about why poomsae was adding a second team member but not the sparring side. D.Turgeon talked with S.McNally about this question - they were leaving it open because of the new height rule. They weren't filling it automatically because of the potential to fill the second spot with the existing team members.

On Pathways questions answered

On March 16, C.Fu reached out to Master Rex Hatfield for assistance with obtaining a list of 10year+athletes for AAC Special Election.

On March 24, C.Fu sent C.Simmons AAC's US Open Feedback.

On March 27, C.Fu emailed Donna noting some outdated USATKD website pages related to coaching.

On March 29, C.Fu and D.Turgeon received an email with questions related to the poomsae pathways. C.Fu responded and no further follow-up so far.

B.Salinaro raised some concerns around the Para team stating there's a whole new team coming and there are some issues with the competition in Brazil. She's working on getting a stable athlete agreement (a version was sent to S.Nelson and A.Gonzalez). A.Gonzalez is currently both coaching and serving as HP manager. USATKD will reopen the coaching application process towards the end of April.

The AAC discussed pluses and deltas at US Open for those who attended and heard from other athletes/coaches/spectators. C.Fu will write up a letter with some feedback for the events staff.
