RE: Preliminary Notice to the Athlete Selection Procedures for the 2028 Olympic Quadrennium

USA Artistic Swimming is committed to providing clarity on the selection process for the Senior National Team and is posting a second preliminary notice to highlight recent changes to the 2025-2028 SNT Selection Procedures.

An addendum to the 2025-2028 SNT Selection Procedures was published on January 13, 2026 to change the minimum age requirement for Phase 7 to **fourteen (14) years of age** or older by December 31, 2028 due to a rule modification announced by World Aquatics in December 2025.

A. Final Evaluation Events for the 2026-2028 Senior National Team:

Phase 7 – Senior National Training Squad SELECTION 3

- April 12 - 13, 2026 in Buffalo, NY
- During Phase 7, USA Artistic Swimming will expand the squad to a maximum of thirty (30) athletes. The exact number of athletes will be determined by the Chief of Sport or their designee and may include remote athletes, as outlined in Section XII of the [2025-2028 SNT Selection Procedures](#). The April 2026 evaluation event in Buffalo will give these athletes the opportunity to secure a position on the Squad.

Phase 8 – 2026-2028 Senior National Team Final Squad SELECTION 3

- May 1-3, 2026 in Los Angeles, CA
- At this event, USA Artistic Swimming will select the top 12 to 16 athletes from the Phase 7 Squad. The exact number of athletes will be determined by the Chief of Sport or their designee.
- Phase 8 is the final Squad selection event for the 2026-2028 Senior National Team.
