

WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO PARTICIPATE

In consideration of being permitted to participate in any way, including travel to and from, the Battle Of Warriors and related events and activities of United States Judo, Inc. (USA Judo), USJA, USJF, ATJA,

MidFlorida Credit Union Event Center, Tournament Directors, Tournament Organizers, Tournament Staff, Florida Judo, Inc.

and Suncoast Warriors Judo, I hereby:

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.

2. Agree that prior to participating, I will inspect the mats, equipment, facilities, competition

pools or divisions and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.

3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, including possible exposure

to and illness from infectious diseases (including but not limited to COVID-19, and severe social and economic losses due to not only my own actions, inactions, or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may

be other risks not known to me or not reasonably foreseeable at this time.

4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages caused by, arising out of, resulting from or following

such injury, permanent disability, or death. I understand that should I elect for myself or my

child to participate in a weight or age category outside of his/her "true" weight/age and/or in

a category with a significant weight disparity, that the risk of injury, permanent disability or death could be increased.

5. Release, waive, discharge and covenant not to sue the United States Judo, Inc., the United States Olympic & Paralympic Committee, United States Judo Federation, United States Judo Association, American Traditional Jujutsu Association, MidFlorida Credit Union Event Center,

Tournament Directors, Tournament Organizers, Tournament Staff, Florida Judo, Inc., Suncoast Warriors Judo,

together with their affiliated clubs, their respective administrators, directors, agents, coaches and other

employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, guardians, supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors, and lessees of premises used to conduct the event, all of whom are hereinafter referred to as "releasee", from any and all claims, demands, losses, actions, causes of actions or damages on account of injury, including permanent disability and death and possible exposure to and illness from infectious diseases (including but not limited to COVID-19, and damage to property (Collectively, "Liabilities"), caused or alleged to be caused in whole or in part by the acts or omissions of the release, even if arising from their negligence, OR OTHERWISE to the fullest extent permitted by law.

6. I understand and agree that I may be drug tested at any time, that I am subject to and will abide by the USADA Protocol for Olympic and Paralympic Movement Testing, its Annexes, and the USOPC National Anti-Doping Policies, and that any dispute related to the foregoing

will be resolved exclusively in arbitration pursuant to the USADA Protocol. Before taking any

7. I agree to be filmed and photographed under conditions approved and authorized by USA Judo, to include the use of my name, biographical information, public appearances, interviews, photographs, portrait and motion pictures and television recordings of my judo performance/participation and grant to USA Judo and Organizers the right to record and make use of the same, and to authorize others to do so in promoting the competition and the success of the judo team on which I compete, to promote the image of USA Judo, its sponsors and advertisers, and the sport of amateur judo, and to fund the activities of the USA Judo.

8. I authorize, and agree to hold harmless, whatever medical personnel that may be present

at the tournament/event to take any action necessary, should I become injured.

9. I represent that I am in good health; that I am not presently, nor will I participate while under the influence of any drug or medication; that no one affiliated with this tournament has encouraged me to enter or made any representations regarding my fitness or ability to participate; that I have read and understood every provision of this release; and that I am legally competent to and freely enter into this waiver, release and assumption of risk agreement.

10. Privacy and personal data I understand that by using my Smoothcomp account to register for this event I am giving the organizer the right to contact me via newsletters, event

reminders and more general promotion of offers or information.

11. I further understand that I am responsible for checking and must check my registration information for the event on the website on the registration list for: weight, belt, academy, age division, and name information by the specified registration check day. I further understand it is my responsibility to check the posted pools and report any errors to Tournament staff via text to 954-599-7138 within 60 minutes of online postings.

12. I further understand that tickets might be sold to spectators to watch the event, that news media and others might cover the tournament and that it may also be videotaped or otherwise shown to audiences around the world. I hereby expressly and irrevocably forever consent to having my likeness shown, publicized, commented and/or reported on; and I do not expect to, and in fact waive any compensation I might otherwise be entitled to as a result thereof.

13. Disputes The organizer hereby expressly reserves the right, in its sole and absolute discretion, with or without cause to deny a potential athlete/competitor's registration/application for permission to compete in the event. The terms athlete and/or competitor may be used interchangeably. If any dispute arises out of, or is any way related to your participation in this event, by entering your registration application, you are hereby expressly waiving and giving up your right to the filing of a lawsuit in city, state, or federal court and a trial by jury. The word "dispute" as used above refers to anything, including claims for injury (which you have already waived) that may have occurred that you claim did not occur at the event.

14. I authorize, and agree to hold harmless, whatever medical personnel that may be present at the tournament/event to take any action necessary, should I become injured. I represent that I am in good health; that I am not presently, nor will I participate while under

the influence of any drug or medication; that no one affiliated with this tournament has encouraged me to enter or made any representations regarding my fitness or ability to participate; that I have read and understood every provision of this release; and that I am legally competent to and freely enter into this waiver, release and assumption of risk agreement.

I AGREE TO PARTICIPATE KNOWING THE RISK AND CONDITIONS INVOLVED AND DO SO ENTIRELY OF MY OWN FREE WILL. I AFFIRM THAT I AM AT LEAST 18 YEARS OF AGE, OR, IF I AM UNDER 18 YEARS OF AGE, I HAVE OBTAINED THE REQUIRED CONSENT OF MY PARENT/GUARDIAN.
