Players need to be current USATT Pro Members . Signed USATT National Team Code of Conduct forms and Waiver will be required by all participants. Players will be required to provide a copy of their current passport or birth certificate to prove eligibility. Please note: If a player has already registered with the ITTF or played National Team Trials for another country, such player is not eligible to enter this tournament.
