**FORMAT: RR/SE:** Players will be assigned to a Round Robin (RR) group of 3-5 players. The top 1-2 players from each (RR) group will advance and compete in the play-off Singles Elimination (SE) stage. **All matches are 3 out of 5 games.**

**RATINGS:** Latest USATT ratings

**ELIGIBILITY: Sanctioned** - USATT membership is required. Members may join or renew at the door. Unrated players will not be allowed to advance into SE bracket. The tournament committee may estimate ratings for unrated players. With the estimated rating, players may advance into SE playoff bracket (must arrive 60 minutes before event start time for rating estimate.)

**DEFAULT POLICY:** All entries must include full payment to be included in the draw(s). All ITTF/USATT regulations apply.

**The tournament committee reserves the right to cancel any event if there are not enough entries.**

**DRESS CODE:** Must abide by the USATT dress code: Shorts, sweatpants, and leggings are allowed. Sneakers ONLY. No white shirts.

I understand that under USATT's Minor Athlete Abuse Prevention Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have **regular contact with or authority over** minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport.

For USATT's MAAP Policy, "regular contact with" is defined as: "ongoing interactions during 12 months wherein an Adult Participant in a role of direct and active engagement with any Minor Athlete(s)"; and "authority over" is defined as: "when one person's position over another person is such that, based on the totality of the circumstances, they have the power or right to direct, control, give orders to, or make decisions for that person. "
