- A. Referee National Testing Plan + Backup
  - i. Current policy, continue to work through Ian Gerrard to schedule online testing.
  - ii. As backup: Ian Gerrard will provide a written examination using questions from the online exam to be held by Ref Comm Asst team that may be used for written examinations if the online testing is not available.
  - iii. Update of online testing to reflect the new rules. Targeting end of February for updates including 2025 rules.
  - iv. There are cases where practical examination is being taken prior to written examination. We will allow this on a case by case basis, but national testing registration must continue to happen in advance of event in order to ensure proper paperwork with USA Judo around SafeSport and HeadsUp. We should note that policy should be clarified for consistency in application for future national testing.
- B. Referee Education Committee not an official USA Judo Committee, but function of referee education and development will continue.

Corinne suggests a clarification of "junior" for broader USA Judo audience consumption. "IJF Junior"? "17-20"?
  - B. Follow up with Saro on providing "White Paper" on False Attack for RC review. Saro will re-distribute to all RC members. RC will have email vote to approve and distribute this document. Feb 26 email vote. Ensure attribution to Saro for his contributions.

    - ii. Ideas for sharing/distributing/encouraging coach engagement in rule definitions.
