Welcome: Mike Campbell, Boxing Operations Senior Manager welcomed everyone and let it be known that Mike McAtee, Executive Director was in a meeting about international relations so unavailable on the call.

LBC Election Year: LBC Board elections will take place in the Fall. Please talk to your LBC Board about who will be returning and start recruiting for the positions and succession planning.

LBC Leader Memberships: LBC Leaders must be a current member of USA Boxing to participate and have Admin Rights in Webpoint. This includes current membership, SafeSport training, and background screening. Also, officials must have an Officials Certification to run weigh-ins and be in the field of play.

Officials Clinics - Chris Walden with the R/J Committee mentioned to contact COO if officials need a clinic and to contact Kevin Hope about Official In Charge (OIC) trainings. There must be an OIC at every event and bigger events like National Golden Gloves will need 2 OICs. Also remember, there must be a registered ringside physician at every event.

MatchTracker information was in newsletter that went out last week. We have 93% reporting, so some matches still need to be entered. Please make sure they are reported. LBC Heroes are also listed in the newsletter and they are a huge help with entering matches. We thank them!
