Budget/Finance Update (Steve)

Cash on hand continues to be of significant concern to USA Racquetball. The financial outcome of the U.S. Open was significantly worse than forecast, resulting in current liabilities exceeding cash on hand. On a positive note, while membership revenue is behind budget on the year, it exceeded budget in October and for the preceding several months. For the first time in 2022, sanction fee revenue exceeded budget in October. Individual contributions continue to exceed budget. However, contributions through the end of the year and into 2023 is important given the current financial situation of the Association.
