# **IMPORTANT ANNOUNCEMENT**

Please note an important update to this year's Nationals schedule regarding the US Junior Team Trials. In a change from previous years, the selection process will now be conducted in two distinct phases.


#### PHASE ONE

Phase One, focused on eliminations, will take place on Thursday and Friday, narrowing the field to the top four athletes in each Junior Elite category.

#### PHASE TWO

These top contenders will then advance to Phase Two on Sunday afternoon, where they will compete in double elimination finals. This new format will apply only to elite kata and kumite categories for athletes ages 12 to 17, and is designed to provide a more competitive, transparent, and efficient selection process.

As a result of this change, all Senior Elite divisions will run to completion on the day of their scheduled competition. A detailed Junior Team Selection Document outlining the full process and criteria will be released soon and posted on **USANKF.org**. We encourage all athletes, coaches, and parents to review it carefully once it is available.

# **REFEREE CREDENTIAL**

Kumite & Kata Referee/Judge Certification Course Fee: \$200

USA Karate will host a Referee/Judge Certification Course Wednesday, July 9th that will issue certifications up to Kumite Referee A & Kata Judge A. You must be a current member in good standing. Referee licenses are available to official and coach members. Your registration fee will cover both Kata and Kumite courses, and every official is encouraged to work to attain both licenses.

USA Karate referees who have attained the Karate Referee standard (Kumite Referee A & Kata Judge A) may participate in the course at no charge. USA Karate referees who have Kumite Referee A are entitled to a 50% discount. Please contact natoffice@usankf.org for more details.

Referees who are not participating in the certification course, but attending the championships are required to register online at usakaratenationals.com.

All referees participating are required to have current Level 3 or Level 4 referee membership. All referees must complete the SafeSport training and the background screening before they are able to register. This can all be done in your Sport80 membership profile. Please plan accordingly background screening can take up to 10 days to complete. If your background is still pending after 10 days you will need to contact NSCI directly to find out the reason for the pending approval. You can contact them on their website www.ncsi.com.

# **COACHES CREDENTIAL**

Credential Fee: \$175

To obtain a Coaches Floor Access Pass Credential, you must register in advance, online by visiting the USA Karate National Championships page at usakaratenationals.com. You must have a current USANKF Level 3



or Level 4 coach member. To register for a coach credential, you must be current in both SafeSport Training and background screening.

SafeSport Training and background screening can be completed from your membership profile on our Sport:80 membership platform. Background Screens have been taking longer than previous years and could take up to 10 days. If your background is still pending after 10 days, you will need to contact NSCI directly to find out the reason for the pending approval. You can contact them on their website www.ncsi.com.

Press Credentials will not be issued to any individual on the USA Karate Banned Member list or the US Center for SafeSport Centralized Disciplinary Database.
