# USOPC INTERNALLY MANAGED SPORTS – BREAKING ATHLETE SELECTION PROCEDURES SUMMER OLYMPIC GAMES, PARIS 2024 AUGUST 11, 2023

\*These procedures were not published six (6) months in advance of the first evaluative event due a delay in publication of the official WDSF Qualification System for the 2024 Olympic Games. #### 1. SELECTION SYSTEM

- 1.1. Provide the minimum eligibility requirements for an athlete to be considered for selection to the Team:
  - 1.1.0. Nationality/Passport requirements:

Athlete must be a national of the United States at the time of nomination.

Athlete must hold a valid U.S. passport that will not expire for six (6) months after the conclusion of the Games.

1.1.1. Minimum International Olympic Committee (IOC) standards for participation:

Any competitor in the Olympic Games must be a national of the country of the National Olympic Committee (NOC) which is entering such competitor. For additional information regarding an athlete who is a national of two or more countries, has changed his or her nationality or acquired a new nationality, refer to the Olympic Charter (Rule 41).

- 1.1.2. Minimum International Federation (IF) standards for participation (if any):
  - Athlete must adhere to the World DanceSport Federation (WDSF)
     Rules and Regulations Manual, Breaking
     (https://www.worlddancesport.org/Rule/Competition/General)
  - Athlete must be part of the WDSF Athletes and Competition License system.
  - Athlete must be born no later than December 31, 2008.
  - Athlete must meet the Paris Olympic Games eligibility requirements by the time of nomination.
  - Athlete must respect and comply with the provisions of the following:
    - o Olympic Charter
    - o Rule 41, Nationality of Competitors

- o Rule 43, World Anti-Doping Code
- Olympic Movement Code on the Prevention of Manipulation of Competitions

# 1.1.3. Other requirements:

- Athlete must be a member of USA Dance, registered as a Breaking Athlete, at the time of nomination.
- Athlete must sign and abide by the USOPC's Code of Conduct for Internally Managed Sport by the time of nomination.
- Athlete must successfully complete all Games Registration requirements by stated deadline.
- Any athlete age 18 or older will be required to undergo a background screen in accordance with the current <u>USOPC Background Check</u> Policy.
- Any athlete age 18 or older as of the Closing Ceremony will be required to remain current with the U.S. Center for SafeSport's education and training requirements in accordance with the <u>USOPC</u> <u>Athlete Safety Policy</u>.

- 7. 2023 WDSF World Championships Breaking
  - a. Breaking for Gold USA Regional Championships:
    - i. Open entry, no invitation necessary

- ii. Divisions are determined by athletes' age at the time of registration, adhering to the WDSF BRRM on Olympic breaking eligibility requirements
- iii. Athletes must complete all registration requirements for the Adult Breaking Category by the stated deadline
- iv. Must be in good standing with the National Federation
- v. Athletes must compete in the pre-selection at one or more of the following BFG USA events to be eligible for the BFG USA National Championships
  - 1. Los Angeles, CA March 4, 2023
  - 2. Minneapolis, MN April 1, 2023
  - 3. New York, NY April 22, 2023
  - 4. Placement in the top four (4) at each Regional Championship automatically secures top sixteen (16) placement(s) at the 2023 Breaking for Gold USA National Championship
- b. Breaking for Gold USA National Championship: Austin, TX May 6, 2023
- c. The last four (4) remaining placements into the top 16 will be determined via a prelim the day of National Championship with participation in at least one Regional Championship as a prerequisite.
- d. The top two (2) placed athletes per gender at the National Championship will qualify for the 2023 WDSF World Championship.
- 8. 2023 Pan American Games (Santiago, Chile): November 3-4, 2023
  - a. 2023 Pan-American Continental Championship (May 27-28, 2023)
    - The top four (4) placed athletes per gender at the 2023 Continental Championship will qualify for the Pan American Games, respecting the maximum quota per NOC.
    - ii. The top two (2) placed athletes per gender at the Continental Championship will qualify for the Olympic Qualifier Series.
  - b. WDSF Breaking for Gold (BfG) World Ranking List as of August 5, 2023
    - i. Eleven (11) quota places per gender will be allocated to the top eleven (11) ranked athletes of the respective Continent in the WDSF BfG World Ranking List, respecting the maximum quota per NOC.
    - ii. If a top eleven (11) ranked athlete already qualified for the Pan American Games, the next highest ranked

- athlete from the respective Continent will qualify for the Pan American Games, respecting the maximum quota per NOC.
- iii. If a top eleven (11) ranked athlete already qualified for the Pan American Games, the next highest ranked athlete from the respective Continent will qualify for the Pan American Games, respecting the maximum quota per NOC.
- 9. Olympic Qualifier Series (OQS):
  - a. The OQS consists of three events held between March June 2024.
  - b. A maximum of three (3) athletes per gender per NOC can qualify for the OQS, with a total of Forty (40) athletes per gender that may compete in the three (3) OQS events.
  - c. Athletes who directly qualified for the Games through the World Championship or Continental Qualifier are not eligible to participate in the OQS.
    - i. The 2<sup>nd</sup> 6<sup>th</sup> highest ranked athletes per gender from the 2023 World Championship.
    - ii. Three (3) athletes per gender from each of the five (5) Continents. For Pan American Athletes:
      - 1. Top two (2) placed athletes per gender from the 2023 Pan Am Continental Championship.
      - 2. Second highest ranked athlete per gender from the 2023 Pan Am Games.
  - d. Athletes must be ranked in the top 14 on the BfG Ranking List on December 31, 2023, to qualify for the OQS.
  - e. BfG Olympic Qualifier ranking points are accumulated at the following events from July 1, 2022 December 31, 2023, with only the athlete's top 4 results counting towards their ranking points:
    - Continental Championship(s)
    - BfG World Series
    - BfG International Series
    - BfG Challenge Series
  - f. Next highest ranked fourteen (14) athletes per gender from the WDSF Ranking List, excluding athletes already qualified to the OQS by other means (8c), will qualify for the OQS.
- 1.3. Step-by-step description of the selection process for the 2024 Olympic Games:
  - Max Team Size: 4
    - o B-Boys: 2

- o B-Girls: 2
- o Quota places are allocated to the athlete(s) by name
- An athlete may qualify for the Games at the 2023 WDSF World Championship Breaking or at the 2023 Pan American Games.
  - Only one (1) athlete per gender per NOC can qualify directly for Games in 2023. Should two (2) athletes from the same country win the aforementioned competitions in 2023, the winner of the earlier competition will qualify directly to Paris 2024. The second athlete will qualify for the OQS and will have to earn an Olympic Berth in that series.
- O An athlete may also qualify for the Games through participation in the Olympic Qualifier Series (OQS), respecting the max quota.

### 1. September 23-24, 2023: 2023 WDSF World Championship (Belgium):

- a. The highest placed athlete per gender will qualify for the 2024 Summer Olympic Games.
- b. If the highest placed athlete already qualified for the Games at the Continental Qualifier, the next highest placed athlete at the World Championship, not yet qualified, will be allocated the quota place at the Games.

# 2. November 3-4, 2023: 2023 Pan American Games (Santiago, Chile):

- a. The highest placed athlete per gender will qualify for the 2024 Summer Olympic Games.
- b. If the highest placed athlete already qualified for the Games at the 2023 WDSF World Championship, the next highest placed athlete at the Pan Am Games, not yet qualified, will be allocated the quota place at the Games.

#### 3. March – June 2024: Olympic Qualifier Series (OQS):

- a. Each of the three (3) OQS events will award ranking points to the athlete. The athlete's total points from all three (3) events will be used in the final OQS Ranking List.
- b. The highest ranked seven (7) athletes per gender, not yet qualified, from the final OQS Ranking List will qualify for the Games, respecting the maximum quota of 2 athletes per gender per NOC.
- c. Two (2) athletes per gender from the top 24 ranked athletes on the final OQS Ranking List will qualify for the Games through Universality places, respecting the maximum quota of 2 athletes per gender per NOC.
- d. One (1) athlete per gender from the final OQS Ranking List will qualify for the Games through host country places if the athlete finishes in the top 24 of the final OQS Ranking List.

In the event of a conflict between this overview and the WDSF Qualification System for the 2024 Olympic Games, the WDSF Qualification System will take precedent.

#### 3. REMOVAL OF ATHLETES

3.1. Prior to submitting athlete entries by name to the USOPC, the USOPC IMS has jurisdiction over potential nominees.

An athlete who is nominated to the Team by USOPC IMS may be removed for any of the following reasons, as determined by USOPC IMS:

- 3.1.1. Voluntary withdrawal. Athlete must submit a written letter to the USOPC Sport Performance Director (Whitney Carter <a href="whitney.carter@usopc.org">whitney.carter@usopc.org</a>).
- 3.1.2. Injury or illness as certified by a physician (or medical staff) approved by the USOPC. If an athlete refuses verification of his/her illness or injury by a physician (or medical staff) approved by the USOPC, his/her injury will be assumed to be debilitating and he/she may be removed.
- 3.1.3. Failure to participate in Mandatory Training and/or Competition as defined in Section 8 of these procedures.
- 3.1.4. Violation of the USOPC's Code of Conduct for Internally Managed Sport.
- 3.1.5. Non-compliance with the eligibility requirements listed in Section 1.1. of these selection procedures.

An athlete who is removed from the Team pursuant to this provision has the right to a hearing per the USOPC's internally managed sport complaint procedures (https://www.teamusa.com/breaking-selection-procedures) and the USOPC Bylaws, Section 9 (https://www.usopc.org/legal/section-9-complaint-form).

3.2. Once athlete entries have been submitted to the USOPC, the USOPC has jurisdiction over the Team, at which time, in addition to any applicable USOPC Internally Managed Sport Code of Conduct, the USOPC's Delegation Conduct Requirements apply, contained in the USOPC Games Delegation Terms. The USOPC

Games Delegation Terms are specific to each Games and made available during the Games registration process; the USOPC's Grievance Procedures and Hearing Process are found within the Delegation Terms. 3.3. An athlete may be removed as a nominee to the Team or from the Team for an adjudicated violation of IOC, WADA, IF, USADA and/or USOPC anti-doping protocol, policies and procedures, as well as the U.S. Center for SafeSport Code, and the USOPC Athlete Safety Policy, as applicable.

#### 4. REPLACEMENT OF ATHLETES

  - 4.1.1. Prior to submission of Entries by Name to the Local Organizing Committee, including any applicable group or committee:

Reallocation of unused Quota Places and Replacements, as outlined by the WDSF in the Paris 2024 Qualification System:

- If an allocated quota place is not confirmed by the NOC by the deadline or is declined by the NOC, the quota place will be reallocated to the next highest-ranked athlete, not yet qualified, at the event at which the quota place was obtained, respecting the maximum quota per NOC. Any quota place that cannot be reallocated through the event at which the quota place was obtained, will be reallocated to the next highest-ranked athlete, not yet qualified, on the final OQS Ranking List, respecting the maximum quota per NOC.
- Unused host country places will be reallocated to the next highest-ranked athlete, not yet qualified, on the final OQS Ranking List, respecting the maximum quota per NOC.
- Unused Universality places will be reallocated to the next highest-ranked athlete, not yet qualified, on the final OQS Ranking List, respecting the maximum quota per NOC.
