- IX. Executive Session
 - A. Reporting forms – detailed discussion and recommended changes to proposed documents – 1) tracking direct hansoku make, 2) coach incident tracking, 3) international trip report form standardization. Documents 1 & 2 will be further tweaked by Ian Gerrard and Keith Bryant to be presented back to the RC prior to the next meeting. Document 3 will be further modified by Gary Berliner, Bobby Donaldson and Ian Gerrard to be presented back to the RC prior to the next RC meeting. Potential utilization of “email me form” to track the info on these 3 forms.
 - B. Gary Berliner moved (Bill Gugino seconded) - Proposed change in eligibility to referee at the Senior Nationals – discussed and passed to add a requirement of officiating at one of the other 3 national championships (JO's, President's Cup, and Youth Nationals) that immediately precedes each Senior Nationals. This is to be effective immediately. This is proposed to help get more appropriate numbers of referees to our national events.
 - C. Recommended Continuity Transfer – status – significant progress was made during a zoom meeting between Russ Scherer and Mike Takata in reviewing current policies and procedures and the reasons for the development of these policies
 - D. Requests for Emeritus Status – Mike Mooney (N3), Jim Carmer (N3), Alyssa Gilkey Zawack (N2) and John Jacobson (N1) Moved by Bill Gugino (seconded by Gary Berliner) – passed unanimously
 - E. Incident at US Open was sent to the RC, reviewed and will be forwarded to the Ethics and Grievance Committee.
 - F. 2025 Program Emphasis and Budget Implications – discussion provided a “flavor” of the desires of the RC for activities during the upcoming quadrennial. Review/update of the Strategic Plan will be very important.
 - G. We need to verify documentation of the policy of removing a competitor from the entire event (not just the division) if given Hansoku Make for action against the spirit of Judo.
 - H. Ralph Palmer (RC Assistant) has been supplying regional patches to numerous National Referees who have been certifying referees below the national level. Russ Scherer will prepare a statement to accompany the patches to better capture these certified referees.
