Dear USA Judo,

I am honored to be nominated to join your board to support USA Judo grow its presence throughout the U.S. While I am not a judo athlete despite sailing across Atlantic and climbing 6K meter mountains with signs protesting for immediate action to stop climate change, I cannot speak to the opportunities you see as professional athletes for judo in the US to grow. Yet, I do see my potential board role as both a catalyst and a doer for USA Judo.

Throughout my career, I have designed and executed many innovative and successful programs, either as a leader, partner, or follower. These programs have ranged from administrative to sustainable business innovation to green finance. It is this specific skill that I possess that I want to offer to USA Judo – "to partner with you so you can achieve your goals".

When I was in high school 35 years ago, I decided to raise \$30K in funds and donated services via an informal NGO that I set up to purchase a used ambulance, fill it with medical equipment, and drive it to northern Mexico as an early precursor to sustainable development.

Next, during college, I worked and studied for five months at sea on the Atlantic Ocean analyzing ocean health and collecting data demonstrating plastic pollution.

Later, 25 years ago, I decided to focus my career on designing innovative solutions to solve the sustainability and climate crises that impact our lives. After obtaining graduate education at the intersection of natural resources, business, and cities – where our greatest sustainability and climate impacts and opportunities lay – I spent the next 20 years working globally leading and participating on innovative solutions to these crises we face.

For example, with colleagues, I partnered in designing the business plan for a private sector program that protects more than 500,000 acres of rainforest in Indonesia. To this day, our project is visible from Google Earth and sequesters millions of tons of carbon dioxide while providing sustainable livelihood options for local communities.

I then worked with various public sector and private sector institutions – USAID, IFC, Calvert Investments, Climate Advisers, and Planet Tracker to name a few – in leadership roles developing innovative research that drove multiple award winning sustainability innovations across multiple sectors of the economy.

From this platform, I launched Responsible Alpha, a corporation that advises institutions on their transition paths to a low-carbon, sustainable, and equitable future. Responsible Alpha is a registered Public Benefit Corporation in the State of Delaware proudly owned by its staff, advisors, and board members.
