I. Roll Call/Call to Order/Conflicts of Interest

Quorum was established and Board Chair Mr. Ragan called the meeting to order at 1:02 pm MT. No conflicts were announced.

II. Point Events

The board and staff discussed the criteria for hosting a point event and how the sanction requests for point events are reviewed and decided upon. A larger number of point events were approved recently so that event hosts could see what goes into hosting these events with the hope of creating more quality events across the country. Allowing several events to be held in the same area resulted in the quality of some events being diluted. We are now taking that information and being more thoughtful in selections and considering the athlete experience and referee staffing when awarding these events.

Motion by Mr. LeForce, seconded by Mr. Johnson, to approve Battle in the Square for a junior level event for 2024. If the date of the event is moved to not conflict with Senior Nationals by two weeks, they will be awarded both junior and senior point events. Motion passed.

A working group will be created to define the criteria for 2025 and going forward to be completed by the November 2024 board meeting.

- Valid for individuals who have not held a USA Judo membership.
- Can be used to attend one USA Judo non-point sanctioned event annually.
