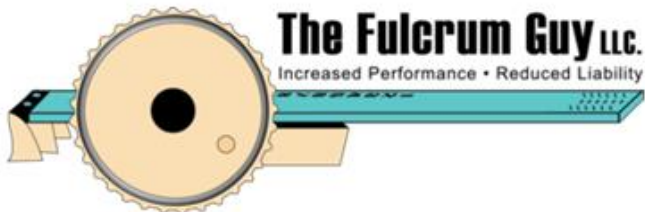

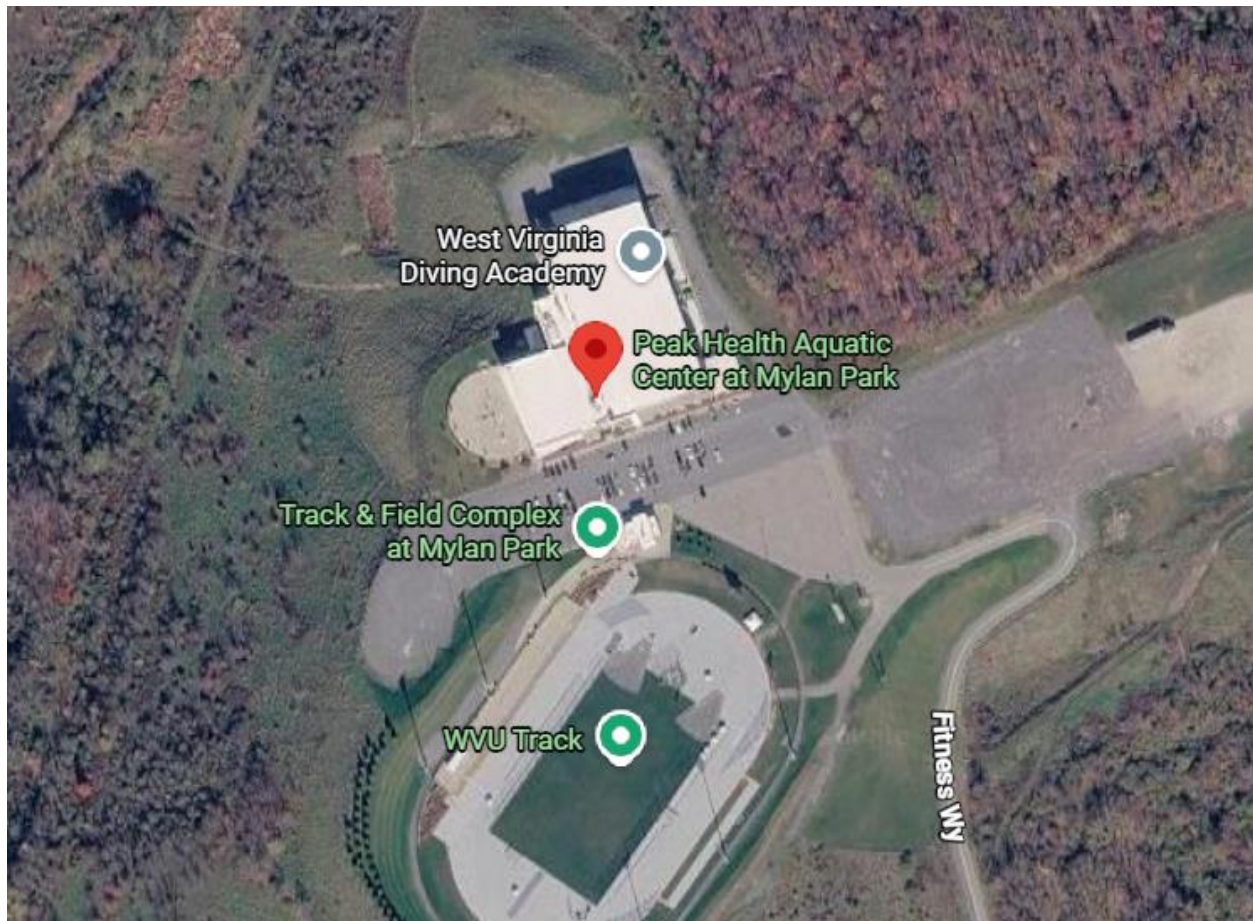

## **FACILITY AND EQUIPMENT**

Competition Pool Equipment: 1M, 3M, 5M, 7.5M and 10M Diving platforms. 2-1M Boards and 2-3M Boards

1 auxiliary 1M board and 1 auxiliary 3M board

Dryland Equipment: One trampoline, one dry board, and some mats

Colorado Gen 7 diving systems and scoreboards.

## **REGISTRATION**

All participants must be "Current" members of USA Diving. All athlete and coach entries must be made online at [www.divemeets.com](http://www.divemeets.com) prior to June 14 at 11:59 PM EST. No athlete or coach will be permitted access to the pool deck without having completed their DiveMeets registration. Athletes may still register after the deadline up until three hours prior to their event with an added \$100 Late Registration fee. **As of the 2026 season, coaches who miss the online registration deadline will incur a \$50 Late Registration fee, which must be paid prior to deck authorization.**

## **DIVE CHANGES**

All dive changes, including payment, MUST be made online through DiveMeets. Athletes may log into their DiveMeets account to review and update their dive sheets within the timeline outlined below:

1. Changes may be made online at no cost before 6:00 PM the night prior to the first day's events, and before 12:00 PM the day prior to all competition days thereafter.
2. After the designated times in point 1, athletes may make changes to their dive sheets online at a cost of \$15 per event up until three hours prior to their event start time.
3. Dive changes will no longer be accepted three hours prior to the corresponding event.

## **PARTICIPANT COMPORTMENT**

USA Diving promotes good sportsmanship from athletes, coaches and spectators. We request your cooperation by supporting the participants and officials in a positive manner. Profanity, racist or sexist comments, or other intimidating actions directed at judges, meet personnel, athletes, coaches, spectators, or team representatives are grounds for removal from the site of competition. Thank you in advance for your cooperation.

Hazing, harassment, intimidation, menacing or bullying, and acts of cyberbullying by members towards any member is strictly prohibited. Retaliation against any person who reports, is thought to have reported, files a complaint or otherwise participates in an investigation or inquiry is also strictly prohibited. False charges shall also be regarded as a serious offense and will result in disciplinary action or other appropriate sanctions. Persons whose behavior is found to be in violation of this policy will be subject to discipline, up to and including expulsion. USA Diving may also make referrals to law enforcement officials.

Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, restrooms, or locker rooms.

Changing into or out of swimsuits other than in locker rooms or designated changing rooms is not appropriate and is prohibited.

## **TECHNICAL MEETING**

The Technical Meeting will be conducted in person on Wednesday, June 24. The meeting time will be communicated at a later date.

Attendance at the Technical Meeting is mandatory for all coaches in order to receive pool deck access for the competition.

Failure to attend the meeting may result in denial of deck credentials per article 106.9 of the 2026 USA Diving Official Rulebook.

## **JUDGING**

This competition will be attended by one AQUA-Certified USA Diving Judge to serve as a Head Referee of the event and two AQUA-Certified USA Diving Judges to serve as Assistant Referees.

## **CHECK-IN TABLE**

The check-in table will be located at the front entrance of the facility.

## **RESTROOMS**

Athletes - Located in the locker rooms at the entrance of the competition area

Coaches/Staff/Adults - Located in the private restrooms located at the entrance of competition area, additional restrooms available in the WVU Locker rooms adjacent to the diving well.

Spectators - Located on the upstairs level.

## **FIRST AID/MEDICAL SERVICES**

Certified lifeguards will be on duty throughout the competition. The lifeguards on duty are the primary first responders for all in-water emergencies and first aid situations. First aid services will be in the Safety Center located in the front of the building and the Trainer Room located next to the dive tower. In the event of an emergency, all participants, coaches, and spectators should immediately notify the nearest lifeguard and follow their instructions.

## **ATHLETIC TRAINING/PHYSIOTHERAPY**

No athletic training and/or physiotherapy services will be provided.

If your team plans on bringing their own athletic trainer or physiotherapist, please contact Riley McNichols, [riley.mcnichols@usadiving.org](mailto:riley.mcnichols@usadiving.org), prior to the late fee registration deadline to ensure that they meet the membership requirements for USA Diving.

## **COACH HOSPITALITY**

Coach hospitality will be located in the middle of the building on the first floor, Coffee, water, light snacks will be available throughout the event, Lunch will be provided each day. Dinner is not provided unless otherwise specified.

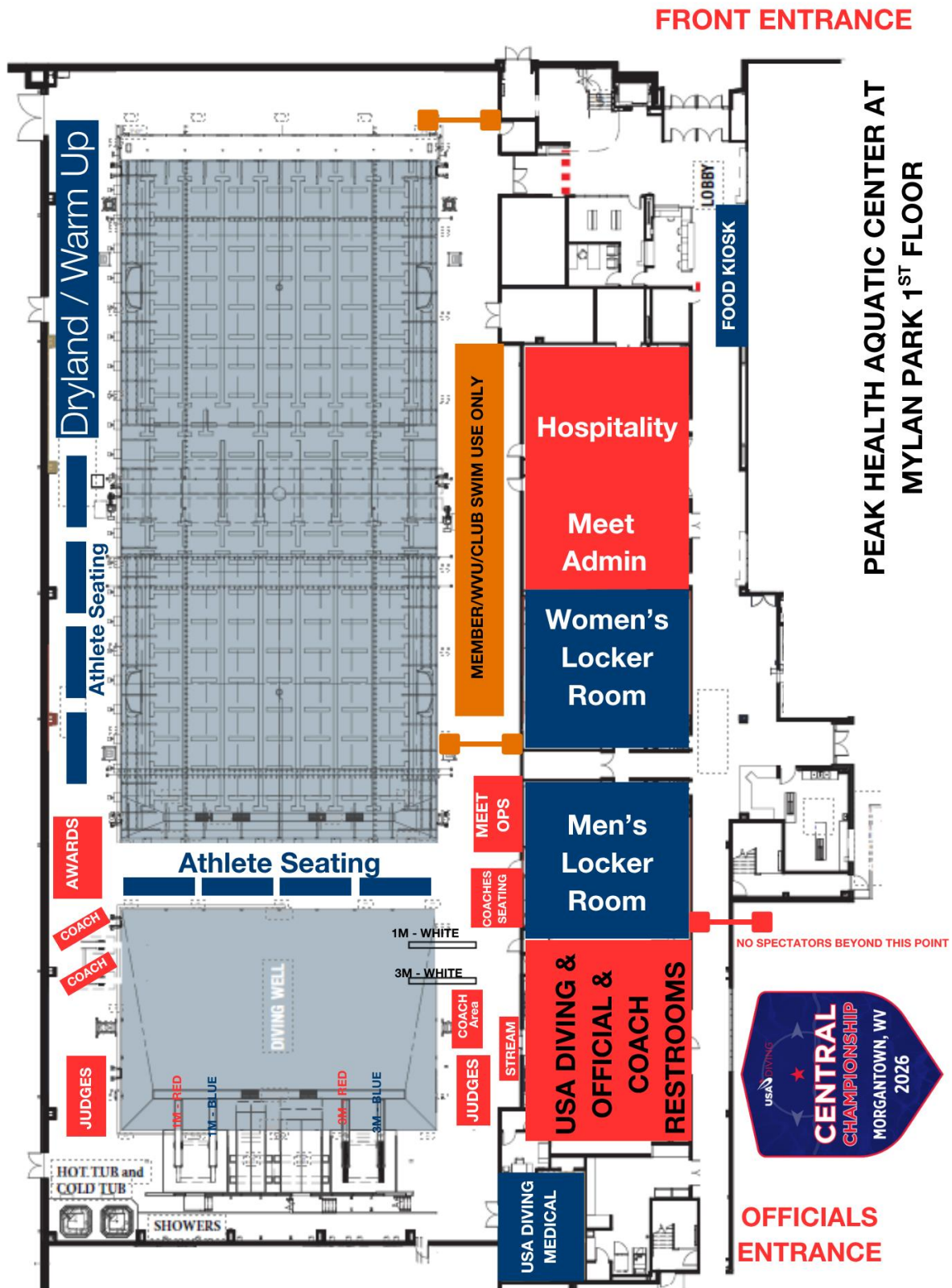

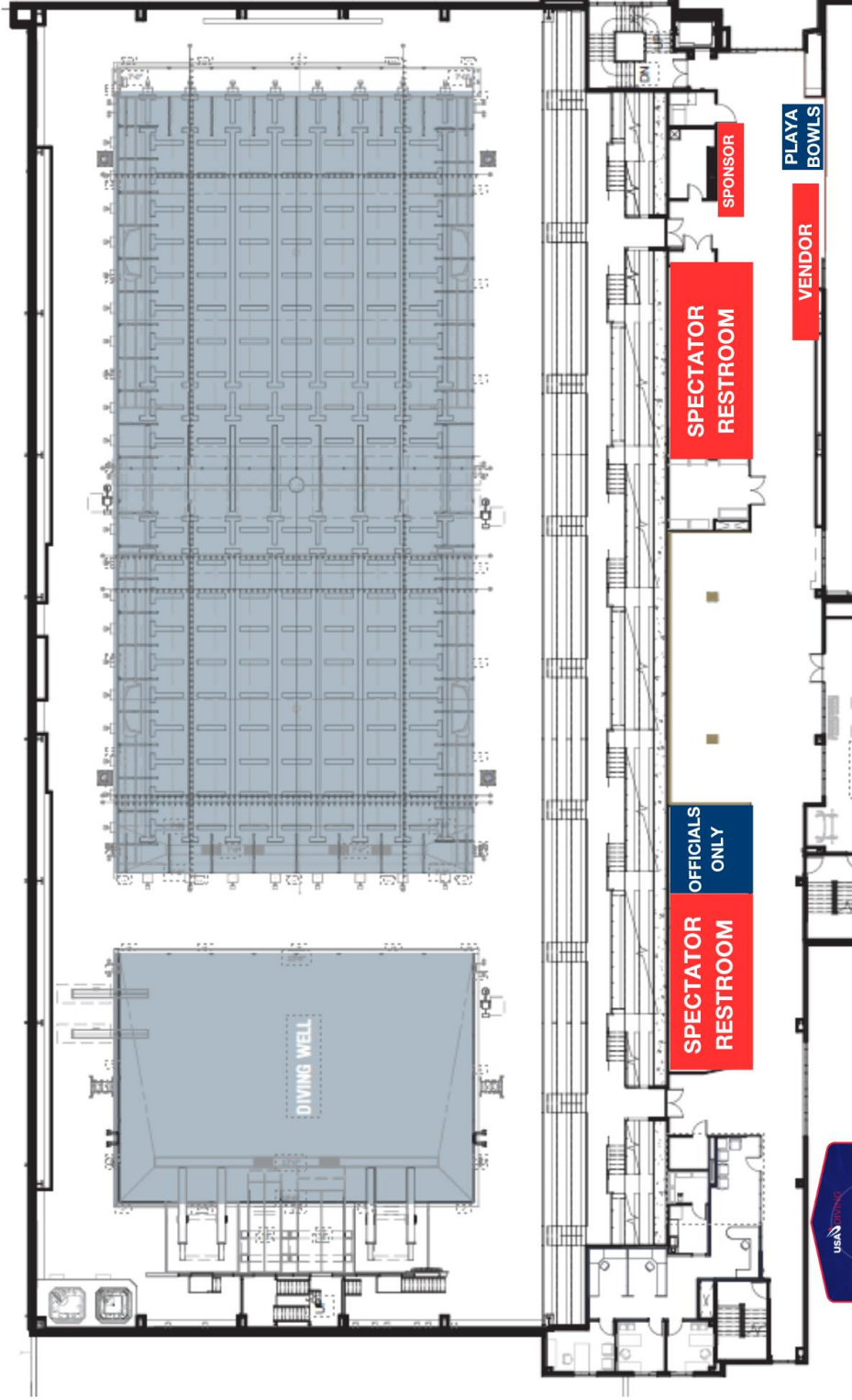
