This document details the pathway for an athlete, pair, or team to earn a spot on the 2024 USA Taekwondo National Poomsae Team for national team events for the following divisions:

The 2024 National Team Trials shall take place in February 2024 Quarter 1 of 2024 (amended 5/23/2023) and will take place in two rounds: the Qualifying Round and the Selection Round. The winners of the Selection Round will serve as the team members for the entire calendar year.

**Note:** Proof of international results must be submitted by the athlete to USATKD in the form of an official bracket or official results sheet published by the tournament organizer.

#### **TEAM TRIAL QUALIFYING ROUND**

The **Qualifying Round** is contested first.

For recognized poomsae, the format of this round is two parts:

**Part 1:** A randomly ordered draw where all contestants perform a single randomly drawn poomsae.

**Part 2:** A different randomly ordered draw where all contestants perform a different single randomly drawn poomsae. No athlete will go first in both rounds.

The winner of the Qualifying round will be the competitor with the highest combined score of the two poomsae. In the case of a tie, the winner is the competitor with the highest presentation score. If the competitors are still tied, all scores received during the competition are considered (without dropping the high and low scores). If the scores are still tied, the competitors will perform a randomly selected poomsae, and the scores from that poomsae will be used to break the tie.

For freestyle poomsae, athletes will contest a single freestyle poomsae with random order.

The winner of the Qualifying Round advances to the Selection Round.

Referees will not see the scores until the end of each division (blind scoring). Athletes and coaches will see the scores after each performance.

**INDIVIDUAL Divisions** - Athletes meeting one of the following criteria in 2023 in the relevant division compete in the Qualifying Round:

- USATKD Major/National Championships Event Silver and Bronze Medalists
- Highest ranked athlete in the USATKD Rankings as of Dec. 31, 2023
- Athletes who have won two golds within the same individual division at a G-1 or G-2 Event (must have at least one opponent)
- Athletes who aged up in 2024 and have won gold, silver or bronze medals at a USATKD Major/National Championships Event in the previous age division in 2023
- Aged up 2023 USATKD National Team members in the same category
- Athletes who have been awarded a wild card from the Wild Card Selection committee (wild card requirement outlined below)
- U30 & U40, O17 Freestyle: Top 20 WT World Ranking

PAIR/TEAM Divisions - The following athletes compete in the Qualifying Round:

• Any age-eligible pair or team that applies by the posted deadline

## **TEAM TRIAL SELECTION ROUND**

The **Selection Round** is contested after the conclusion of the Qualifying Round.

**For recognized poomsae,** this round is contested according to the Team Trials format (see addendum) where each athlete performs all 8 (or 7) recognized poomsae for their division, and a winner is declared based on the results.

For freestyle poomsae, the format of this round is two parts:

**Part 1:** A randomly ordered draw where all contestants perform one freestyle poomsae. **Part 2:** Athletes will perform in reverse order, from the lowest place (first) to highest place (last) in Part 1, where all contestants perform one freestyle poomsae (the same routine may be used for each part). The winner of the Selection Round Part 2 is the winner of the team trial.

Referees will not see the scores until the end of each division (blind scoring). Athletes and coaches will see the scores after each performance.

**INDIVIDUAL Divisions** - Athletes accomplishing one of the following criteria in 2023 in the relevant division compete in the Selection Round\*\*:

- Winner of the Qualification Round
- 2023 National Team Member\*
- USATKD Major/National Championships Gold Medalist
- International Dominant Athlete
- Aging up International Dominant athlete

**PAIR/TEAM Divisions** - Athletes accomplishing one of the following criteria in 2023 in the relevant division compete in the Selection Round\*\*:

- Winner of the Qualification Round
- 2023 National Team Member\*
- USATKD Major/National Championships Gold Medalist
- International Dominant Pair/Team
- Aging up International Dominant Pair/Team

<sup>\*</sup> Benefits of being selected the National Team member only apply to the winner of the team trials/automatically qualified team member; any athlete who acts as an alternate in a National Team event does not receive these benefits.

<sup>\*\*</sup> If no athletes contest the Selection Round, then the top four individuals, pairs or teams from the Qualifying round progress to the Selection Round. If there are four or fewer entries in the

Qualifying round and no athletes contest the Selection Round, then all athletes will immediately proceed to the Selection Round without contesting the Qualifying Round.

The winner of the Selection round is named the 2024 USATKD National Poomsae Team Member.

# **International Dominant Athlete**

An international dominant athlete, pair, or team is one who has proven to be dominant in international competition by accomplishing one of the following criteria in the relevant division in 2023:

- Win three golds at a G-1 or G-2 Event (must have at least one opponent)
- Win a gold medal at a WT G-4 or higher event (must have at least one opponent)
- U30 & U40, O17 Freestyle Individual Only: Achieve #1-4 WT ranking in the world on Dec. 31, 2023
- There may be more than one International Dominant athlete

## Clarification of international qualification through WT G-rated Events

ALL divisions with at least 2 contestants at a WT G-rated poomsae event will be considered as criteria for inclusion in the 2024 Team Trials. In other words, not only the WT-ranked poomsae divisions, but all divisions contested at that event will contribute to an athlete's eligibility. (amended 5/23/2023)

#### Wild Card Applicants (Individual Divisions)

Wild card applicants will be **considered** by the Wild Card Selection Committee if they have a proven record of international medals at World Taekwondo events, and if they can provide a compelling reason why they did not qualify through the other pathways described in this document but still deserve to be in the team trials.

Individuals should apply for the wild card:

- 8 weeks before the first date of team trials competition,
- OR within 1 week of the team trials being announced by USATKD, whichever is later.

Applicants should email bbrand@usatkd.org with the following information:

- 1) Name of division
- 2) Athlete's full name
- 3) Athlete's USATKD membership number
- 4) Clear explanation of the way in which the athletes have fulfilled the wild card criteria

# **Selection Committee**

The Selection Committee responsible for determining dominant athlete status and wild cards will be comprised of the following individuals:

#### Minimum National Team Trials Eligibility Requirements

- I. Citizenship:
- a. Athlete meets eligibility and nationality requirements as presented by USA Taekwondo in compliance with the minimum International Federation standards for participation. b. All athletes must be U.S. Citizens in order to participate in the team trials.
- 2. Minimum IF standards for participation:
- a. World Taekwondo (WT); Rules of Competition, Article 4.Contestants, Section 1 <a href="http://www.worldtaekwondo.org/rules-wt/rules.html">http://www.worldtaekwondo.org/rules-wt/rules.html</a>
- Holder of the nationality of the participating team.
- One recommended by the WT National Taekwondo Association.
- Holder of Taekwondo Dan certificate issued by the Kukkiwon or WT.
- 3. Other requirements:
- a. Athlete must be a USA Taekwondo member in good standing.
- II. Removal of Athletes

An athlete who is to be nominated to the Team by USA Taekwondo may be removed from the nominations for any of the following reasons, as determined by USA Taekwondo.

# A. Voluntary withdrawal.

Athlete must submit a written letter to the USA Taekwondo CEO. Injury or illness as certified by USATKD physician (or medical staff). If an athlete refuses verification of their illness or injury by a USATKD physician (or medical staff), his/her injury will be assumed to be disabling and he/she may be removed.

#### B. Violation of the NGB's Code of Conduct.

An athlete who may be removed from the Team pursuant to this provision has the right to a hearing per the NGB's Bylaws (USATKD Bylaws, Section 15, Complaint Procedures) or USOPC Bylaws, Article 9.

## C. Violation of the NGB's Athlete Agreement.

An athlete who may be removed from the Team pursuant to this provision has the right to a hearing per the NGB's Bylaws (USATKD Bylaws, Section 15, Complaint Procedures) or USOPC Bylaws, Article 9.

# D. Doping violations

An athlete may be removed from Nomination or from the Team at any time for violation of IOC, WADA, WT, USADA and/or USOPC anti-doping protocol, policies and procedures. In such instances, the adjudication process will be managed through the United States Anti-Doping Agency.

# III. Replacement of Athletes

Should circumstances arise in which the 1st place athlete needs to be removed for any of the reasons listed above, the athlete who places 2nd in the same division of team trial will serve as the replacement athlete. The 3rd place athlete will be the 3rd replacement athlete if needed. The 4th place athlete will be the 4th replacement athlete if needed. After this, the team spot will remain vacant.

The following documents are required to be signed by an athlete as a condition of nomination to the U.S. National Team, and are included as attachments:

Any change in the selection procedures caused by a change in IOC and/or WT and/or PATU rules and regulations will be distributed to the affected athletes immediately. The selection criteria are based on the latest information available to USA Taekwondo. However, the selections are always subject to unforeseen, intervening circumstances, and realistically may not have accounted for every possible contingency. (amended 5/23/2023)

**COMPETITION FORMAT: Selection Round** 

## **Recognized Poomsae Format: 8 Poomsae**

With the selection of the very best athlete in mind, the method of selection for Recognized Poomsae Divisions shall include the performance of all of the eight (seven for cadet 12-14 and youth 6-11) required poomsae for each division.

Each Recognized Poomsae Division will perform eight (or seven) poomsae, one at a time per round: all competitors will perform the first randomly selected poomsae, followed by all competitors performing the second poomsae, and so forth.

There will be a random competitor order. The algorithm used to randomize the competitors will ensure that no competitor will perform first for any two consecutive poomsae. Performing first will be equally distributed among all competitors.

The selection of the winner will be based on two methods of calculating the results.

1. **Cumulative Score Method**: The first method will be by cumulative score of all rounds of competition. At the end of eight (or seven) rounds, the scores across all eight (seven) poomsae for each athlete are totaled. The athlete who has the highest total score will be declared the winner of this method.

In the case of a tie, the winner is the competitor with the highest presentation score. If the competitors are still tied, all scores received during the competition are considered (without dropping the high and low scores). If the scores are still tied, the competitors will perform a randomly selected poomsae, and the scores from that poomsae will be used to break the tie.

2. **Rounds Won Method**: The second method will be by placement during each round of poomsae. Each round a first, second, third and fourth place will be awarded to the competitors and the number of wins will be recorded across all rounds. At the end of eight (or seven) rounds, the number of round wins will be listed as the highest number of 1st places, number of 2nd places, number of 3rd places and number of 4th places. The competitor with the highest number of 1st place wins. If there is a tie, then the number of 2nd place, then number of 3rd place become a factor. For example, Competitor A with 5 first place wins beats Competitor B with 3 first place and 5 second place wins. Or Competitor A with 4 first place, 3 second place and 1 third place beats Competitor B with 4 first place, 2 second place and 1 third place.

If the same athlete places first in both methods of calculating the winner, then that athlete is the uncontested winner. In the event that any different athlete(s) places higher using the second method and records more round wins than the cumulative score winner, those athletes will have the right to challenge the winner to a tie breaker round.

The tie breaker between methods will use a single elimination format. The athletes qualifying will be seeded as the Cumulative Score winner seeded number 1 and the Round winner seeded number 2, with subsequent Round winners, if any, seeded next. Two forms will be randomly selected by the Events Director, and the round will be run using WT single elimination format rules. The winner will be named the Team Member.

Alternates, if needed, will be selected from the cumulative score results. The non-winning athlete who has the highest cumulative score is the first alternate. The non-winning athlete who has the second highest cumulative score is the second alternate, and the non-winning athlete with the third highest cumulative score is the third alternate. After this, the team spot will remain vacant if there were 4 or more contestants. If there were 3 or fewer contestants, alternates may be taken from the highest placement for the Qualifying Round to fill 3 total alternate positions.

# **Amendment to Recognized Poomsae Team Trials Format - 1.50 Point Gap Rule:**

If at any point past the fourth round of competition, a competitor has simultaneously won at least 4 rounds, and achieved a cumulative score that is 1.50 or higher than the second place competitor, then that competitor will be declared the winner of the team trials. The remaining competitors must complete the competition to determine alternate standings.

For the remaining competitors after a winner is declared, if at any point during rounds 5-8, the leading competitor's cumulative score exceeds the next highest competitor by 1.50 or more, then that competitor secures the leading place among the group and no longer has to compete. The remaining competitors will compete until all players receive a standing or win by point gap.

Example 1: After 4 rounds, the standing among 3 competitors is:

Competitor A: 29.80, 0 Rounds won

Competitor B: 29.60, 0 Rounds won

Competitor C: 31.55, 4 Rounds won

At this point, Competitor C would be declared the winner, and Competitors A and B would continue to compete until: 1) either all 8 rounds are complete, OR 2) one of the competitor's cumulative scores has exceeded the other's by 1.50 or more.

Example 2: After 4 rounds, the standing among 3 competitors is:

Competitor A: 29.80, 1 Rounds won

Competitor B: 29.60, 0 Rounds won

Competitor C: 31.55, 3 Rounds won

At this point, all competitors would continue until both the 1.50 point gap and 4 rounds won criteria are simultaneously achieved by a player, or until 8 rounds are complete. (amended 5/23/2023)

## Freestyle Poomsae Format: Two Part Process

Part 1: A randomly ordered draw where all contestants perform one freestyle poomsae

**Part 2:** Athletes will perform in reverse order, from the lowest place (first) to highest place (last) in Part 1, where all contestants perform one freestyle poomsae. The winner of the Selection Round Part 2 is the winner of the team trial.

In the case of a tied score, the tie will be broken according to the USATKD rules: The winner will be the competitor with the highest technical skills score. In the case that the scores are still tied, the competitor with the highest total points including the total points of all judges without dropping the high and low score is the winner. If it is still tied, the tied competitors will perform one freestyle poomsae, and the competitor with the highest score will be the winner.
