Reporting forms USA Judo responded that they will not accept Coach Incident Reporting forms from the RC and recommended that issues be raised to Tournament Director(s) who may at their discretion include as part of their report to USA Judo. For consistency referee and player incident reports may be used at the discretion of the event Chief Referee to document for the Tournament Director(s). Reasoning given was that enforcement of coach behavior should not be a referee function but a tournament director function.

- VII. Executive Session
 - A. New IJF Rules USA Judo RC has submitted recommendations, Corinne confirmed adoption by USA Judo, not needing USA Judo Approval. Recommend we distribute to active USA judo referees (email?)
 - B. USA Judo 2025 SOP Document, working with USA Judo to address the following clause:
 - i. "Qualified mat officials should be used. USA Judo certified referees must be used on every mat. If a sufficient number of certified referees is not available, then one certified referee should be assigned to each mat area. Local and regional referees must be certified by the USA Judo Referee Commission or an IJF-A certified USA Judo Referee. The regional and local certifications will include a current USA Judo membership with completed SafeSport training, background screen and concussion training. Exceptions are made regarding SafeSport and Background screening for any referee under the age of 18"
 - C. Forwarded proposal for Rules Education Clinic to USA Judo CEO, Coach Committee, Athletes Council to explore possibility of Rules Seminar for Referees, Coaches and Athletes, potentially in conjunction with US Open event. Waiting on USA Judo response on budget for follow up meeting. This is an evolution of the proposal from February RC meeting from Saro Balagezyan.

 - G. Initial 2025 RC Budget Update Final budget not yet available. USA Judo Events will be budgeted for 1 Chief Referee, 3 evaluators, and 7 referees per mat, including mat chiefs. USA judo lodging allocation will cut off at this point. Referees signing up after the limit is reached may participate, but are not guaranteed a lodging allocation.

- A. Proposed by Ian Gerrard Revised International Travel Report -- Report Template shared with RC via email earlier this week. Edits made per recommendation of David Smith. Reports will be shared with RC co-chairs as gatekeepers. Inquiries about specific events can be directed to Mike Takata or Gary Berliner.
- B. Proposed by Mike Takata: No changes will be made to the current evaluation system for individual events at this time. Proposing removal of weighted ranking annual summary calculation for N4 and B4 referees. Alternatively, we will provide raw data of event attendance and ranking upon RC request so that RC Members may consider their own interpretations of relative value of quantity of events, quality of ratings, international participation, USA Judo participation, "head to head" rankings when referees participate in the same event, or any other factors reflected in the data. Current summarization process in my opinion is an overly-complex system applying unclearly defined fixed weightings to various events.
