- We have been busy getting back to boxing and getting High Performance back into the country after Tokyo.
- We had a very good Games with excellent representation by our boxers. Even though we had a tough draw, we are thankful for the medal outcome.
- Key dates: registration for Nationals begins October 18<sup>th</sup>.
- Membership is growing at about 37,700 (which is only 3,300 shy of the budgeted amount)
- We have compiled data that boxing can be done safely....have documented over 11,000 bouts conducted since reopening last July.
