- complete one of the practical driving experience options listed below each calendar year;
- successfully pass a Motor Vehicle Record (MVR) Review once every two years; and •
- successfully complete one of the clinic options shown in the USA Water Ski & Wake Sports Trained Boat Driver Resources . once every four years

USA Water Ski & Wake Sports will notify you via e-mail when your MVR Review and clinic are due for renewal.

INSTRUCTIONS – Return completed/signed form to USA Water Ski & Wake Sports' Officials' Program Coordinator via e-mail, fax or mail by <u>DECEMBER 1ST each year</u>. Be sure to retain a copy for your records.
