FORMAT: RR/SE: Players will be assigned to a Round Robin (RR) group of 3-5 players. The top 1-2 players from each (RR) group will advance and compete in the play-off Singles Elimination (SE) stage. All matches are 3 out of 5 games.

RATINGS: Latest USATT rating

ELIGIBILITY: Sanctioned. This tournament is open to all players rated U2200, U21000, U1900, U1800, U1700, U1500, U1450, U1300, U1200, U1150, U1000, U950, U900. Unrated players can participate in the RR stage but cannot advance to the SE stage. However, unrated players may come in 30 min before the start of the event to be evaluated by coaches/Pros to receive an estimated rating so they will be eligible to advance into SE.

DEFAULT POLICY: All entries must include full payment to be included in the draw(s). All ITTF/USATT regulations apply.
The tournament committee reserves the right to cancel any event if there are insufficient entries.

DRESS CODE: Must abide by the USATT dress code: Shorts, sweatpants, and leggings are allowed. Sneakers ONLY. No white shirts.

For USATT's MAAP Policy, "regular contact with" is defined as: "ongoing interactions during 12 months wherein an Adult Participant in a role of direct and active engagement with any Minor Athlete(s)"; and "authority over" is defined as: "when one person's position over another person is such that, based on the totality of the circumstances, they have the power or right to direct, control, give orders to, or make decisions for that person. "
