Events:

National Events:

- September 9 16, 2023 Last Chance Qualifier Pueblo, CO
 - Larger event than anticipated with 400 boxers. Final opportunity for qualification to Olympic Trials.
- Mar 9 16, 2024 Title to be announced Albuquerque, NM
 - It will be an open event, as it is not an Olympic year. Details to come.

Other

Discussed a variety of regional events and their success. Expressed our objective toward the growth

host, advertise, or administer a regional event.

Operations:

- Introduced the new sanction review for multi-ring/ multi- day sanctions. Sanction holders will complete a questionnaire that asks them to explain the logistics of the event, to ensure a smooth and seamless experience for participants. Andrew will conduct a weekly review of said sanctions and reach out to those sanction holders directly.

Membership:

- Stacy discussed the LBC election process and outlined common terms (i.e., acclimation). Also, explained how members can read candidate statements via the usa boxing website. Simply voting will tally the vote between October 1 15. Lynette further clarified LBC procedures, such as who gets to vote, are LBCs allowed to defer their business considering prospective candidates.
- Lynette informed LBCs they will receive notice to consider fee revisions to membership and sanction fees for 2024. Those will be sent in the coming weeks.
