RE: Preliminary Notice to the Athlete Selection Procedures for the 2026 Youth Olympic Games

To provide information in a timely manner, IMS is releasing this Preliminary Notice to the Athlete Selection Procedures for the 2026 Youth Olympic Games (Games). This document is being written as a complement, and not a substitute to the 2026 Youth Olympic Games Athlete Selection Procedures. Additional communication will be released by IMS once the Athlete Selection Procedures have been completed.

**A. Anticipated Athlete Eligibility Criteria:**

- Athletes cannot be older than 17 years old at the time of the closing ceremony of the Games.
- Athletes must comply with all Badminton World Federation (BWF) and International Olympic Committee (IOC) eligibility requirements.
- Athletes must be a national of the United States and hold a valid U.S. passport that will not expire for six months after the conclusion of the Games.
- Athletes must adhere to all IMS, USADA, USOPC, WADA, BWF and IOC anti-doping protocols, policies, and procedures including participation in Out-of-Competition Testing, if applicable.
- Athletes must comply with the [USOPC Background Check Policy](#) and [USOPC Athlete Safety Policy](#).
- Athletes must meet the following Games eligibility requirements:
  - Have participated in at least one (1) BWF sanctioned tournament on or after September 24, 2025; or
  - Appear in the BWF World Junior Ranking **by September 1, 2026**
- ~~It is unknown at this time when the final date to appear in the rankings will be to meet this requirement. However, it is anticipated that athletes will need to appear on this ranking list in Summer 2026. Once more information is released by the Youth Olympic Games Organizing Committee, the final date to appear in the BWF World Junior Ranking will be shared by USOPC IMS.~~

**B. BWF Qualification System Overview:**

- **Comply with all BWF eligibility requirements which will be posted here once available:**

- **The maximum Team size is one (1) male athlete and one (1) female athlete.**

~~The Dakar 2026 Youth Olympic Games Qualification Systems Manual for Badminton has not been published by the BWF so the maximum Team size cannot be confirmed at this time.~~

**C. Anticipated Evaluation Events:**

It is intended that athletes being considered for nomination to the 2026 Youth Olympic Games will be evaluated on their performance at any of the below listed events. Participation in these events is not a requirement, however, ranking points from BWF-sanctioned tournaments and placement on the BWF World Junior Rankings is anticipated to be the basis for nomination to the Games. Ranking points will start accumulating on September 24, 2025.



