High Performance: The USA Triathlon Foundation's Ignite Olympic and Paralympic Dreams program provides financial support, resources, and opportunities to development and elite triathletes, including our paratriathletes, that are pursuing national and international competition. The program helps athletes overcome barriers to achieving their performance goals by providing grants and support that contribute to sustained excellence at the highest levels of the sport. Through this investment, the Foundation helps strengthen the pipeline of U.S. athletes representing the country on the Olympic and Paralympic stage.

4b (Code:) (Expenses \$ 313,552. including grants of \$ 298,135.) (Revenue \$)

Youth: The USA Triathlon Foundation's Youth program expands access to multisport opportunities for children and young athletes nationwide. Through grants and community support, the program helps develop youth-focused coaches, clubs, schools, and events that provide training opportunities, equipment, and resources. These efforts introduce young athletes to the benefits of swim-bike-run while supporting the development of the next generation of multisport athletes, coaches, and leaders.

Other: Philanthropy also empowers USA Triathlon to act with agility, whether expanding programs for development athletes beyond the NCAA pathway, enhancing daily training environments through investment in assistant coaches, or scaling high-impact initiatives and programs that drive meaningful progress across the sport.
