

Board of Directors Meeting Minutes February 22, 2023

Meeting Called to Order: Tyson Lee, Board Chairperson called the meeting to order at 6:04 pm MST. Absent: Brian Ceballo, Rahim Gonzales, Ebony Haliburton, Omari Jones, and Jonathan Prin. Quorum was established.

Staff present: Mike McAtee, Lisa Peterson, and Stacy Arredondo.

Board Chairperson Report: Lee welcomed everyone to the meeting. He introduced our new board members, Angelica Colantuoni, Christy Halbert, Elise Seignolle, and Darryl Smith and let them tell a little bit about themselves. Lee stated that we are excited to have the new board members and reported that we are having our best year yet. He thanked the staff and board members. Lee stated that we are looking for volunteers for the Board Marketing and Strategic Plan Task Forces. Arredondo will send out another announcement and then Lee will see who fits where.

Board Officer Elections (Resolution 1):

A MOTION was made (Colon) and seconded (Trombetta) to elect Brian Ceballo to 2nd Vice Chairperson and Elise Seignolle to Treasurer by acclamation. (See Resolution 1). MOTION PASSED.

2022 USA Boxing Year in Review: Mike McAtee, Executive Director reported on department infographics (see attached) and stated that 2022 was a successful year. Darryl Smith asked about membership/ donation drives and McAtee explained that it is the Foundation's purpose is to raise funds.

Peterson welcomed our new Treasurer, Elise Seignolle and thanked the Audit Committee. Peterson explained the updated infographic, which is attached and highlighted revenue funds including from the Foundation. Peterson also mentioned sponsorship revenue and complimented staff for obtaining them. 2022 ends with a net income of \$394,212. Trombetta explained that the Audit Committee reviewed the Profit & Loss and in particular sponsorships for the potential financial growth sponsorships bring. Trombetta complimented Peterson. Seignolle added that she is pleased to see the financials. McAtee announced that USA Boxing found out today that a grant from the Daniels Fund for \$400,000 this year and for \$400,000 next year was awarded. These funds are program specific including some for Grassroots programming in addition to High Performance. Buller asked about USOPC grants for social media hits, McAtee explained that is the digital media agreement.

A MOTION was made (Colon) and seconded (Butler) to accept the attached 2022 Fourth Quarter / End of Year Finance Report (See Resolution 2). MOTION PASSED.







