Junior Team - Skaters that qualified (with funding times) for the previous seasons Junior World Championships (are now Junior National Team members). May receive limited services while training in Salt Lake City.

USS and the athletes recognize that many of the services or benefits outlined above are driven through partnership agreements. These agreements may be amended, terminated and or new partnerships may be put in place during the course of the competition season.
