COACHING CREDENTIAL and COACHING AUTHORIZATION STICKER

USATT APPROVED COACH: A “USATT Approved Coach” (i.e., a person who has completed USATT and/or ITTF Training; current full Safe Sport Compliance; current USATT Gold Membership) will be granted one (non-transferrable) Coaching Credential or Wristband for the duration of the tournament free of charge. The Coaching Credential or Wristband is valid for entry into the playing hall.

Safe Sport Compliance and USATT Gold Membership must be current and valid through July 9, 2026.

COACHING AUTHORIZATION STICKER: For persons who are not Approved/Credentialed USATT Coaches, in order to coach and/or provide in-match tournament playing advice to a registered playing participant from the coach’s corner, such person must display a Coaching Authorization Sticker. See USATT Tournament Coaching Policy on Page Three of Prospectus. There is no charge for a Coaching Authorization Sticker.

Unless a person is a registered player in the 2026 US Nationals or a USATT Approved/Credentialed Coach, each person must pay either the Day Fee or Tournament Pass Fee to gain entry into the Playing Hall.

USATT TOURNAMENT COACHING POLICY

An adult (a person over the age of 18) must be fully Safe Sport Compliant to coach and/or provide tournament in-match playing advice from the coach’s corner to a Minor Athlete (person under the age of 18).

A parent and/or legal guardian is permitted to coach his or her own child without being Safe Sport Compliant.

An adult is permitted to coach and/or provide tournament in-match playing advice from the coach’s corner to another Adult Participant without being Safe Sport Compliant.

A minor is permitted to coach and/or provide tournament in-match playing advice from the coach’s corner to another Minor Athlete without being Safe Sport Compliant. A minor is NOT PERMITTED to coach an Adult Participant (who is not the minor’s parent or legal guardian), unless the Adult Participant has completed training offered by the US Center for SafeSport.

2026 US NATIONALS - MANDATORY COACHING CREDENTIAL / COACHING AUTHORIZATION STICKER

All persons serving as a coach and/or providing tournament in-match playing advice from the coach’s corner to another participant are required to properly display a Coaching Credential, Coaching Authorization Wristband, or a Coaching Sticker on a credential indicating that such person has been approved by the Tournament Director to serve in this capacity.

USATT Approved Coaches will receive, free of charge, a Credential or Wristband which authorizes such person to coach and/or provide in-match playing advice from the coach’s corner to all participants, including Minor Athletes, at the 2026 US Nationals.

Persons who are fully Safe Sport Compliant (but are not USATT Approved Coaches), can receive, upon request, a Coaching Sticker authorizing them to coach and/or provide in-match playing advice from the coach’s corner to all participants, including Minor Athletes, at the 2026 US Nationals.

Parents/Legal Guardians seeking to coach and/or provide in-match playing advice to their own child can receive, upon request, a Coaching Sticker authorizing them to sit in the coach’s corner for their child’s matches.

Adults who are not Safe Sport Compliant but are seeking to provide in-match playing advice from the coach’s corner to Adult Participants can receive, upon request, a Coaching Sticker authorizing them to sit in the coach’s corner for such matches.

Minors seeking to coach and/or provide in-match playing advice from the coach’s corner to Minor Athletes can receive, upon request, a Coaching Sticker authorizing them to sit in the coach’s corner for such matches.

ENTRY INTO THE PLAYING HALL FOR THE 2026 US NATIONALS

There is no cost to obtain a Coaching Authorization Sticker, however all persons, except for Credentialed Players and USATT Credentialed Coaches, must purchase a Day Pass or a Full Tournament Pass to gain entry into the playing hall.

USATT SAFE SPORT POLICY AWARENESS AND COMPLIANCE

I understand USATT’s Safe Sport Policy including the organization’s Coaching Policy, which requires that all persons who are engaged in coaching activities at USATT Affiliated Member Clubs and/or providing in match playing advice to Minor Athletes USATT Sanctioned Tournaments, except parents or legal guardians coaching their own children, must be fully Safe Sport Compliant, which includes completing SafeSport Training offered by the US Center for SafeSport every year and undergoing a criminal background screen every two years.

I understand, pursuant to USATT’s Minor Athlete Abuse Prevention (MAAP) Policy, all participants at USATT Sanctioned Tournaments who are over the age of 18 and have regular contact with or authority over minor athletes must complete annual SafeSport Training offered by the US Center for SafeSport.

For the purposes of USATT’s MAAP Policy, “regular contact with” is defined as: “ongoing interactions during a 12-month period wherein an Adult Participant is in a role of direct and active engagement with any Minor Athlete(s)”; and “authority over” is defined as: “when one person’s position over another person is such that, based on the totality of the circumstances, they have the power or right to direct, control, give orders to, or make decisions for that person.”

**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF THE RISK

Release and Waiver of Liability, Assumption of the Risk and Indemnity Agreement

Dates: July 3 – July 9, 2026

IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or minor child, our personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I and/or minor-aged child understand and assume the nature and risks of Table Tennis Activities, including but not limited to risks involved in the sport itself together with all risks, known and unknown, associated with gatherings of people ("Activities"), including the exposure to COVID-19, coronavirus, or other infectious organisms or diseases; and that I and/or minor child are qualified, in good health, and in proper physical condition to participate in such Activities. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or minor child will immediately discontinue further participation in the Activities.

FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, DISMEMBERMENT, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by me and/or minor child's own actions, or inaction, or the actions or inaction of others participating in the Activities, the condition in which the Activities take place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or minor child incur as a result of my participation in such Activities.

HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USA TABLE TENNIS, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activities take place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.

By registering for the 2026 US National Table Tennis Championships, all participants are subject to possible selection for drug testing as conducted by the US Anti-Doping Agency.

MEDICAL AND TRANSPORTATION RELEASE – I hereby give consent for the organizers of the 2026 US National Table Tennis Championships to provide me and/or my minor aged child with athletic trainer and emergency medical treatment. I swear and affirm that I am in good physical condition and I am not aware of any previous or existing diseases or injury that would result in my being injured. I further acknowledge that I have procured on my own and currently hold valid and adequate insurance for such loss, damage, or injury and if I do not have valid and adequate insurance, I accept full responsibility for the cost of the loss, damage, or injury that might occur as a result of my participation in the 2026 US National Table Tennis Championships. I give my consent to participate in any and all emergency transportation associated with activities during the 2026 US National Table Tennis Championships, in the event I become incapacitated or otherwise not conscious to give direct consent and I accept full responsibility for all costs associated with all emergency transportation as deemed necessary. Further, as the parent/guardian of a participating minor athlete, I hereby give my consent for complete medical treatment and emergency transportation services as deemed necessary beyond the on-site athletic trainer or emergency medical treatment provided.

MEDIA AND PHOTO RELEASE – Any image, photographic, or otherwise, taken of tournament play or within the official venue is essentially the property of USA Table Tennis regardless of the Approved status of the recording instrument or photographer. Entrants agree to allow their voice and likeness in such images to be reproduced in connection with USA Table Tennis by way of any medium. USA Table Tennis is not responsible for, nor can they control, the use of camera phones inside the venue. Participants are hereby notified of this policy.

The finals of the Men’s and Women’s Singles will be held in the evening hours on July 8, 2026. Entry will be free for all persons with a proper credential (players, coaches, media, etc...) or a Day Pass for July 8, 2026. Seating will be first come, first served.

Admission to the Playing Hall

Players in the 2026 US Nationals will receive a “Player Credential” at the time of registration that will serve to permit daily entry into the Playing Hall. Please note that lost Player Credentials will only be replaced upon payment of \$35. All other persons must purchase a Spectator Day Pass or Spectator Tournament Pass to gain entry into the Playing Hall.

Eligibility

Each and every player seeking to participate in Championship Events at the 2026 US National Table Tennis Championships (**Events No. 1 – 31 AND 73 - 109**) must be a Citizen of the United States of America. Proof of US Citizenship must be presented with Registration.

In addition, each and every player seeking to participate in the below events must be eligible to represent the United States of America in: (i) the Olympic Games, the Pan American Games, and the ITTF World Championships; or (ii) the Paralympic Games, the Parapan American Games, and the ITTF World Para Championships as of July 3, 2026 (EVENT NUMBERS IN PARENTHESES):

Eligibility to represent the United States of America in the Olympic Games, Pan American Games and the ITTF World Championships or the Paralympics, the Parapan American Games, and the ITTF World Para Championships will be determined by the Rules of those Events as determined by USA Table Tennis.

Each and every player seeking to participate in Non-Championship Events (Ratings Events, Classic Events, Para Singles Events, Parkinson Events, and Doubles Events) (**Event Nos. 32 – 72 and 110 - 116**) must be, at a minimum, a resident of the United States of America. Proof of Residency is required at the time of Registration.

Each and every player seeking to participate in the 2026 US National Table Tennis Championships must be a “Gold” or “Lifetime” USATT Member. USATT Memberships must be valid through **July 9, 2026**.

Rules

The 2026 US National Table Tennis Championship matches will be conducted under the ITTF Laws of Table Tennis. Rules of match play are determined by the Referee. All matters, issues, guidelines, and ancillary decisions beyond match play related to sponsors and tournament venue decoration will be determined by the Tournament Director in accordance with USATT Policies and Procedures, including the USATT Member Code of Conduct. An Event with fewer than four (4) registered participants may be cancelled at the discretion of the Tournament Director.

Match Scoring

All matches at the 2026 US National Table Tennis Championships will utilize 11-point Best-of-Five Game Rules with the exception of Hardbat and Sandpaper events (see Hardbat and Sandpaper info). Men's Singles and Women's Singles Open Championship events will be 11-Point Best-of-Five Games until the Quarterfinals Stage, when the event will implement an 11-Point Best-of-Seven Games.

Equipment

Tables and Nets: Butterfly

Balls: Nittaku Premium 40+ (White)

Floor: For the 2026 US Nationals, USATT expects that all courts will have matted flooring. However, it is possible that some courts may be established on concrete flooring.

Racket Testing: Rackets must abide by all ITTF regulations including, but not limited to, flatness, racket covering thickness, even thickness and continuity of layers, and presence of harmful or volatile substances. All participants are subject to random testing throughout the event.

Clothing: The USATT Dress Code will be enforced. No white clothing will be allowed. Players must wear their respective assigned player number or have their name printed on the back of their shirt when competing. Names must be large and visible to spectators. It is recommended that each player come to the table with two distinctively different colored shirts, as referees will sometimes require opponents to have different colored shirts in important matches with spectators.

Event Registration – Starting Times and Maximum Number of Events

Participants in the 2026 US Nationals may not enter two events that are scheduled to start at the same time.

The Maximum Number of Events that a Participant in the 2026 US Nationals may register for is ten (10).

The Maximum Number of Events that a Participant in the 2026 US Nationals may register for on a single day is three (3).

Event Scheduling

Events are not guaranteed to be completed on the same day that they begin, and USATT suggests that participants plan accordingly. No refunds will be given for early departure. Each event will begin on the date/time designated on the form, and it will continue at regular intervals until a champion has been determined. An entrant's signature on the tournament entry form acknowledges that the dates are acceptable for participation in the registered events regardless of any holidays, federal, state, local, religious, or foreign. All events will be completed by the conclusion of tournament action, which is expected to be in the late afternoon on July 9, 2026.

Any event may be cancelled if the event contains fewer than four players or pairs, as appropriate. (For Event Fee Participants, the cost of an event cancelled for lack of appropriate numbers of participants will be refunded.)

Draws will be available 24 hours prior to the start of each event. For example, for an event that starts on July 4, at 10am, the draw will be available on July 3 at 10am

Adding / Dropping Events

For Participants electing the Early Bird Flat Fee Entry Structure, events may be added or dropped up to May 15, 2026. After this date, no additional events may be added to your registration, events may only be dropped.

For Participants electing the Early Bird Event Fee Pricing Structure, the participant may substitute one event already purchased for another up to May 31, 2026; such participant may also purchase (for \$80.00) and add additional event(s) up to May 15, 2026.

Scheduling Conflicts

All Participants must report conflicts at least 30 minutes prior to the conflict scheduled time. Participants are responsible for notifying the Control Desk. Conflicts will be resolved by the Conflict Resolution Station at the Control Desk. Players must follow the direction of the USATT tournament committee's decision regarding the sequence of play in the resolution of Conflicts.

Please note that your timely check-in helps us to keep the tournament running as scheduled. The earlier that you report a conflict of which you are aware, the more likely the Tournament will run on time. Timely check-in and conflict filing allows that some matches may be played EARLY to avoid the delays that arise with unavoidable conflicts.

Mandatory Match Check-In

For Round Robin match play, players **must register** with the Control desk at least **30 minutes before** their group is scheduled to start playing. Immediately after registering with the Control Desk, the player must go to his or her assigned table and be prepared to begin play. Even if you are not the first match, you must be ready to play ten minutes before the scheduled match. Failure to comply with this requirement may result in default.

For Single Elimination matches, players **must register** with the Control desk at least **30 minutes before** their assigned match start time. Immediately after registering with the Control Desk, the player must then go to his or her assigned table and be prepared to begin play.

The only exception is documented conflict resolution sheet prepared in advance by the Conflict Resolution Station (CRS) at the Control Desk.

Defaults

An Athlete who defaults in any event at the 2026 US Nationals is considered to have defaulted from that event completely, fully and finally. A default in an event may also be declared to be a full and final withdrawal from the remainder of the Tournament as determined by the Tournament Referee (TR) or his/her designee (example: Deputy Referee). The TR will base that decision upon the nature and circumstances of the default as they pertain to match play and the rules of the sport. All decisions by the TR regarding defaults shall be final without provision for appeal.

Any other issue unrelated to match play or the rules of the sport that might necessitate a default from the tournament will be determined at the sole discretion of the Tournament Director (TD) or his/her designee (example: Deputy Tournament Director).

Seeding

Unless otherwise stated in this Prospectus, seeding for all events will be determined by a player's USATT Rating as of June 16, 2026 ("**Seeding Cut-Off Date**").

Automatic Seeding in the Main Draw of Certain Events

The **top eight (8) players** entered in the Men's Singles will be automatically seeded in the Main Draw of this event. The **top four (4) players** entered in the Women's Singles, Men's U-21 Singles, Women's U-21 Singles, and the U-2600 Ratings Event will be automatically seeded in the Main Draw of those events (i.e., those players will not participate in the Group Stage).

Seeding in all events at the 2026 US Nationals will be based on: (i) ITTF World Ranking (up to and including Number 100); then (ii) the USATT Rating List generated on June 16, 2026.

Age Events

Players assume the responsibility of entering the appropriate age events. Players who are over/under the age limit of an event will automatically be entered in the correct age event.

Birth Dates for Age Events

U 21 - Born on or After January 1, 2005 - Must be 21 or under as of December 31, 2026

U 19 - Born on or after January 1, 2007 - Must be 19 or under as of December 31, 2026

U 17 - Born on or after January 1, 2009 - Must be 17 or under as of December 31, 2026

U 15 - Born on or after January 1, 2011 - Must be 15 or under as of December 31, 2026

U 13 - Born on or after January 1, 2013 - Must be 13 or under as of December 31, 2026

U 11 - Born on or after January 1, 2015 - Must be 11 or under as of December 31, 2026

40 +: Born on or before December 31, 1986 - Must be 40 or older as of December 31, 2026

50 +: Born on or before December 31, 1976 - Must be 50 or older as of December 31, 2026

55 +: Born on or before December 31, 1971 - Must be 55 or older as of December 31, 2026

60 +: Born on or before December 31, 1966 - Must be 60 or older as of December 31, 2026

65 +: Born on or before December 31, 1961 - Must be 65 or older as of December 31, 2026

70 +: Born on or before December 31, 1956 - Must be 70 or older as of December 31, 2026

75 +: Born on or before December 31, 1951 - Must be 75 or older as of December 31, 2026

Ratings Events

Eligibility for ratings events will be determined by a player's USATT Rating as of May 15, 2026 ("Ratings Cut-Off Date").

Seeding for ratings events will be determined by a player's USATT Rating as of June 16, 2026 ("Seeding Cut-Off Date").

Ratings events will have Round Robin Groups of 3-4 players dependent upon actual number of registrations in each event as determined by the organizing committee and Tournament Director. One winner per Round Robin Group will advance to a second round Single Elimination stage. SOME events will be designated as single elimination from the start. If two ratings events with the same start time are entered, the Tournament Committee will choose on behalf of the player which event is to be played.

Unrated Players

Players may enter any event for which they are otherwise eligible. Players who are unrated on the Ratings Cut-Off Date (May 15, 2026) will not advance to the single elimination stage of rating-restricted RR events, unless they acquire an eligible rating prior to June 16, 2026. Players who enter a rating-restricted event without a rating and who acquire a rating between the Ratings Cutoff Date (May 15, 2026) and the Seeding Cutoff Date (June 16, 2026) will be permitted to advance provided their new rating meets the event's requirements. If a player enters a ratings event and is unrated as of the Ratings Cutoff Date (May 15, 2026) and prior to the Seeding Cutoff Date (June 16, 2026) that player obtains a rating that is above the ratings restriction of the event entered, that player will be removed from the event. Unrated players are not permitted to enter rating-restricted single elimination events.

Ratings Events for Juniors and Adults

Players entering the Junior Ratings events must be under 19 as of December 31, 2026 (born on or after January 1, 2008).

Players entering the Adult Ratings Events must be 19 or older as of December 31, 2026 (born on or before December 31, 2007).

Doubles Ratings Events

Players MUST be rated under 2500 to participate in the U4000 Doubles and under 2000 to participate in U3100 Doubles. Players without a rating as of the Ratings Cut-Off Date (May 15, 2026) cannot enter a Doubles Ratings Event.

Doubles Partners

Players MUST enter with a designated partner in all Doubles Events. USA Table Tennis will NOT arrange for a doubles partner. USATT cannot be responsible for the nonparticipation of your selected Doubles Partner. It is the responsibility of the players to contact his/her doubles partner about participating in the event.

Family Generational Doubles

Eligible pairs for the Family Generational Doubles are (i) a parent/legal guardian with his or her own child; (ii) a grandparent with his or her own grandchild; (iii) a great-grandparent with his or her own great-grandchild.

Open Sandpaper SE and U1700 Sandpaper RR:

The same rules as Hardbat (see below) will apply except that in Sandpaper events the table tennis paddle blade must be covered in sandpaper. Nittaku Premium 40+ (White) balls will be used. All matches will be 2 out of 3 to 21 points. Eligibility and seeding for the Sandpaper Open SE event and the U1700 Sandpaper RR event will be determined by the player's Sandpaper Rating at the seeding cutoff date: June 16, 2026.

Hardbat and Sandpaper Events Rules

Hardbat rules, as adopted by the USATT Classic Table Tennis Committee, will be used for all Hardbat and Sandpaper events. All rules and all current ratings (Hardbat, Sandpaper, Wood) are only available at <https://ratings.pinkponk.cz/>. For all Hardbat and Sandpaper events, round robin groups will be formed in groups of up to five (5) players per group. As in all events, a question of racket legality is the decision of the Tournament Referee. Rackets complying with all requirements of the rules for Hardbat rackets shall be legal. This means that participants must use an all-wood blade with short pimped-up rubber and no sponge. These events do not count for USATT ratings points. Both eligibility and seeding for the Hardbat events will be determined by the player's Hardbat rating at the seeding cutoff date: June 16, 2026. All matches will be the best of 3 games to 21. Balls: Nittaku Premium 40+ (White).

Para Events

If there are fewer than four (4) entrants in a Para singles event class grouping, the tournament director may elect to combine classification groups. For example, if there are only three (3) entrants in Para Class 1 - 2 Singles, the tournament director may create Para Class 1 - 5 Singles event.

For Para Events and Parkinson Event, there will be a consolation bracket for those who don't advance from initial round robin.

Para Doubles

For the Para Doubles Seated (8), the combined Class for the two players cannot exceed 8. For the Para Doubles Standing (18), the combined Class for the two players cannot exceed 18.

Withdrawals - Refunds

For Participants electing the flat fee payment structure, a \$75 processing fee will be charged to any participant who withdraws from the tournament prior to June 1, 2026. There will be NO REFUNDS given after this date except for injured players with a signed doctor's note. Please note that there is still a \$75 processing fee for those persons who withdraw after presenting a signed doctor's note. Withdrawal notification must be made in writing to the USATT National Office in order to receive a refund.

For Participants electing the event fee structure, there are NO REFUNDS. However, if a participant presents a signed doctor's note and requests to withdraw from the tournament, that participant will be refunded the fees paid under the EVENT FEE PRICING structure minus a \$75 processing fee. Withdrawal notification must be in writing at USATT National Office in order to receive a refund.

Publications

Display and/or distribution of any brochures, posters, literature, or written material at the tournament venue is strictly prohibited unless previously approved by USATT.

Films/videotapes

Video recording of competition is limited to personal, non-commercial use. Video recording may not interfere with athletes, officials, or event operations. Live streaming, rebroadcasting, or professional filming without authorization is prohibited. USATT reserves all media rights.

Cancellation Without Fault

USATT will refund 50% of all entry fees paid by participants if the US Nationals event is cancelled or partially cancelled due to acts of God, force majeure, war within the continental U.S., governmental authority, disaster strikes, civil disorder, or curtailment of transportation services that prevent at least 50% or more of USATT participation from attending the event.

Prize Money Checks

Prize money will not be paid for no-shows, splits, dumping, or defaults (except for verified cases of injury, illness, or emergency). Prize money will not be awarded in events that have fewer than 3 participants (singles) or pairs (doubles). Prize money checks which are not claimed at the tournament site will be mailed to the winner within one month of the conclusion of the tournament. Prize money checks that are not cashed within 120 days will be forfeited.

COVID POLICY

IF YOU TEST POSITIVE, YOU MUST VACATE THE CONVENTION CENTER IMMEDIATELY AND NOT RETURN FOR A MINIMUM OF THREE DAYS UPON WHICH TIME YOU WILL BE RE-TESTED AGAIN. ANYONE FAILING TO COMPLY WILL FORFEIT ALL MATCHES PLAYED.
