Eligibility: Entrants must be USATT members, or purchase USATT membership or tournament pass. Only players in good standing with USATT allowed.

Start Time: Facility opens at 12:15 PM. Check no later than 12:45 PM.

Terms: Only prepaid entries accepted / No refunds for no shows

Officials: Tournament Director and Referee - Bill Englebreth, IU/NR

Equipment: 8 Butterfly Centerfold 25 tables and nets + practice tables; good lighting & conditions. Only approved USATT equipment will be used; 3 star orange JOOLA 40+ balls.

Clothing: Darker colors recommended; no orange or yellow shirts; rubber soled shoes only. Players must follow all USATT tournament dress code regulations.

Rules: USATT sanctioned tournament; all USATT regulations apply. **Unrated players cannot advance to SE except Class A.**

Format: (all matches 3/5 to 11 points)

Preliminary Round - 8 round robin groups of 4 players - all advance to Class A or B

Main Round - Class A: 4 round robin groups of 4 players, 2 advance to SE

Class B: 4 round robin groups of 4 players, 2 advance to SE

Elimination Round: Both Classes have quarterfinals, semifinals, finals

Cancellation Deadline: Midnight on February 23, 2024. After this time all entries will be calculated into the prize payouts.

Prizes:

First place through semifinalist will receive medals
