Rules and Policies

- All ITTF and additional USATT regulations apply. Only ITTF and USATT approved equipment will be used: 10 blue Butterfly Centerfold Table Tennis Table and Nittaku white 3-star 40+ Premium plastic balls.
- Tournament management reserves the right to modify, combine, or cancel events, limit total participants or total entries by event. If event(s) are cancelled the fees for this event will be refunded.
- Starting from September 21st 2025, players who have not made the entry fee payment will be removed from the participant list automatically and the spot will be made open to the next paying participant. Platforms like Omni Pong and or stadium compete may not reflect the actual list of participants and number of available spots which are maintained separately by CITTA organizing committee
- Players must register at the desk or check in online at stadium compete no later than 30 minutes before the starting time of their respective event(s). Default time is the starting time for the event and or the match.
- > No prizes will be awarded for splits, defaults and no-shows. Unrated Players are not eligible to win trophy and prize money in rating events 2-8.
- The Venue will be open for practice/warmup from 8:00 am. Pre-match warm-up will be limited to 2 minutes.
- > All events will start with a round robin (RR) group of 3 to 4 players followed by Single Elimination. For all events **only one (1) player advances** out of each RR group to Single Elimination (SE)
- Unrated players will be given an estimated rating based on a recommendation by a coach who knows the player or by visual evaluation of the player by a coach, whenever possible. Unrated players may not win prize money or trophies except for the Open Event.
- Withdrawals through September 28th, 2025, will be eligible for full refunds. After that date refunds will only be issued if there is someone on the waiting list who fills the vacated spot and / or other situations approved by USATT.
- Any image, photographic, video or otherwise, taken of the tournament play or within the official venue is essentially the property of CITTA (Chicago International Table Tennis Academy) and USATT. Entrants agree to allow their picture, video, voice and likeness to be reproduced in connection with CITTA or USATT by way of any medium.
- > The most recent ratings available will be used for seeding the events
- Boosters or Glues with VOC are Not permitted inside the venue and No re glue inside the venue. No Smoking, No Vaping and / or No Use of all Tobacco products at the Venue.
- > Event Eligibility Rating Date is August 29th, 2025.
- > All matches are best of 3 out of the 5 games to 11 points as per ITTF/USATT rules
- USATT Dress Code applies. The main body of the shirts, shorts and skirts must be significantly different than the color of the ball (white). No white shirts, shorts and skirts allowed. Tracksuits,

Hoodies, Jeans etc. are not allowed during matches. Only ITTF and USATT approved clothing.

> All Trophies must be picked up at the control desk. Trophy will not be shipped.
