TOPICS

Events:

- Registration for the Last Chance Qualifier is open.
- Have OICs and Administrators verify memberships the morning of the event.
- Women's Championships hosted over 275 bouts. We had special activities like mitt competitions.
- Last Chance Qualifier
 - September 9 - 16 in Pueblo, CO.
 - It will be limited to 200-250 boxers.
- National Championships & Olympic Trials
 - December 2 – 9, Lafayette, LA
 - Boxers must receive invites to Olympic Trials.
 - National Championships will have stringent bout minimum and winning percentages.
 - Boxers will be allowed to apply for an exemption.
 - Pee Wees won't be boxing at Nationals.
- March 2024 Event will be in Albuquerque, NM

Membership:

- Membership is very busy. Getting about 100 new members per day
- Introduced new membership staff member, Rhonda Smith.
- A reminder that *Boxing Day in America* is coming in November.
- Reminded LBCs about the document approval process. (birth certificates, physicals, etc.). This takes about 24 hours to process. To reduce membership's workload, LBC administrators have access to upload those documents, as well.

High Performance:

- We are getting a new Coaching Education Coordinator. Until then, direct inquiries to Matt Johnson.
- Bronze and Silver clinics will be offered at both Last Chance Qualifier and Olympic Trials.
- High Performance is working on silver re-certification. Details to come.
- TEAM USA had new coaching opportunities for junior camps.
- Registration is open for the upcoming junior camp. 3 boxers per weight class, with 2 on the waitlist. Most weight classes are full. Registration is 895.00. Chaperones are not allowed. Registration closes August 11.
- Youth team are currently in camp, preparing for Brandenburg Cup tournament in Lindow, Germany, from August 12 – 20, 2023.
- The Pan-American games are the last week of October, which is the first opportunity to secure a spot in the Olympics.

 - New officers take office in January.
 - Applications will be submitted via a new on-line process.

- Coaching You Up
 - Similar to the Knockout COVID campaign of 2021, where sanction holders can receive up to \$1,500.00 to help pay for sanction fees.
 - Change to the requirements stating only first ten attendees ages 55+ are required to attend.
 - All sanctions September through March 2024.

- Be aware of what is posted on Social Media, as it can cause confusion.

- Gyms4Grants
 - USA Boxing will begin accepting applications September 1, ending September 15th
 - Recipients will receive a free non-athlete and club membership, along with other items. A total value of 1000.00.
