# To the Modern Pentathlon Federations in the NORCECA area:

The Modern Pentathlon Association of Guatemala has the pleasure of inviting a delegation from your country to participate in the individual, relay by gender and mixed relays modalities. The competition will take place in the City of Guatemala, in the facilities of Colegio Suizo Americano from the 3<sup>rd</sup> to the 11<sup>th</sup> of December 2023, according to the following program:

# **COMPETITION FORMAT / RULES:**

The competition will be carried out according to the current UIPM rules.

Delegations are kindly reminded that the Competition registration system is mandatory trough the competition form A, B and C. For enrollment to be registered, it is mandatory for all athletes to possess their valid UIPM registration. Please get in touch with UIPM and/or your Federation if any of your athletes don't possess this license number.









Each country (a maximum of 4 boys and 4 girls per category U19, U17) and (a maximum of 8 boys and 8 girls per category U13, U15), the LOC have the right to accept more registration based on the availability in each age category. For Laser Run Competition, and Laser Run with Obstacle NO maximum number of athletes required.

#### **COMPETITION VENUES:**

The competition will be held in Colegio Suizo Americano (Boulevard San Isidro and 12th street zone 16, Acatán), a facility that has the necessary equipment and infrastructure for a high-quality Modern Pentathlon Championship.

Fencing facilities: The school has an indoor arena that will be accommodated for fencing piste. This space will have dedicated areas for coaches and spectators.

Swimming facilities: There is an indoor 25-meter pool with 6 lanes for the swimming competition. Same as with the fencing facility, there will be dedicated areas for coaches and for spectators.

Laser run: Shooting range: 18 targets (16 + 2 reserve) there will be no air-cylinders. Running will be outdoors (asphalt and sand).

Obstacle Course: [in the case there is an obstacle course, it will be placed on a clay track and basketball courts].

Internet connection: The school offers an internet connection that will allow for transmission and result download in real time, ensuring timely track of the competition.

# **TRANSPORTATION:**

Transportation is guaranteed from Guatemala City's airport to the hotel and for return journey on the arrival and departure days, upon reception of form "C".

### **VISAS:**

The visa process is exclusive to the people who attend the event (in case it is needed for your nationality) LOC will provide invitation letters for those who request them.

# **INSURANCE:**

According to UIPM rules, all members of the attending delegation should insure themselves in case of accidental injury and illness.

The organizer will not accept any financial liability for loss, injury or illness that occurred to any participant and or member of the delegation.









### **MEDICAL SERVICES:**

An ambulance will be hired to provide aid in any kind of emergency or eventuality that may arise during the competition.

#### **FINANCIAL**:

For delegations (athletes, coaches, officials, supporters) reserving conditions for accommodation in Hotel Barceló are as follows:

Single room **USD\$.120.00** per person per night Double room **USD\$.98.00** per person per night

Delegations wishing to arrange their own accommodation must pay an accreditation fee per participant (athlete, coach or official) to the LOC. The amount of the Accreditation fee is set at **USD 50** per day per person. For this we will provide lunch for the competitions payed days and allow access to the official competition sites at the same days.

LOC only accepts payments by transfer. No cash payments are accepted upon arrival to Guatemala.

It is mandatory for Final Entry Form C to be submitted by October 28<sup>th</sup> for the delegation to be taken into consideration.

Following the closure of the registration system, an NF must enter the competition with at least one pentathlete. Any failure to take part having sent their final entries will pay a fine of **USD\$200.00** per person to the LOC.
