2025 Pentathlon and UIPM International Competitions (UIPM CAT A events)

Selection Process Document

1. Introduction

1.1 USA Pentathlon Multisport (USAPM) is the National Governing Body for Modern Pentathlon in the United States and is affiliated to the UIPM. With this it selects athletes and teams for international Pentathlon events and UIPM Category A/B events, including World Cups, World Cup Final, World Championships, and the Olympic Games.

1.2 This document will be subject to periodic review and may be amended post review to ensure both that it takes into account any external rule or policy amendments and includes any relevant feedback. In the case of any amendments, an updated policy will be published and circulated to all athletes.

1.3 This document outlines the process and criteria that USAPM will use to determine which athletes it wishes to select for events at the respective competitions in 2025.

1.4 The USAPM Performance Committee (PPC) are made up of but not limited to the USAPM CEO, Performance Director or another individual appointed by the Performance Director, USAPM Coaches, USAPM Board of Directors, USAPM AAC representatives, and expert advisors.

1.5 This selection document will cover events in 2025 listed below but not limited to:

1.5.1. UIPM World Cup 1, 2, 3 1.5.2 UIPM World Championships

1.6 This selection document does not include the Pan American Games or the Olympic Games.

2.1 To be eligible to be selected for USAPM as part of the team, each athlete shall:

2.1.1. be eligible to compete, in accordance with the rules and regulations as set out in the 'UIPM Competition Rules and Regulations General Aspect Section 1.19.4"

2.1.2. Hold a vaild UIPM License

2.1.3. Not be subject to any sanction issued by USAPM, USADA, WADA, or the UIPM

2.1.4 Have signed a USAPM Athlete Agreement

2.1.5. Comply with any USAPM Regulations, Code of Conduct, Policies, SafeSport and a Background Check

2.1.6. Not serving a ban from participation in the sport for any reason at the time of selection and/or at the time of the event

2.1.7 Conduct themselves as suitable ambassadors for USAPM and the sport of Pentathlon, and act in a manner befitting a representative of USAPM and Team USA.

3. 2025 World Cup 1, 2, 3 and World Championships Selection

3.1 Goal

2. Eligibility

3.1.1. The 2025 primary goal of selection to the UIPM World Cup 1, 2, 3 and the UIPM World Championships is to expose select athletes to high level UIPM Category A competitions for both testing and evaluation.

3.2. Selection Process

3.2.1. Selection for World Cup 1-3 and Senior World Championships will be at the sole discretion of the Pentathlon Performance Committee (PPC) who will consider all but not limited to the following; athlete's performances compared to the 2025 Elite Performance Metrics (EPM), past performance history, potential, training history, trajectory of the athletes training and competitions over the 2025 season, coaches recommendation, demonstrating the commitment to planned team training, athletes compliance to USAPM rules, regulations, and policies, and any other reasonable points the PPC deems necessary. 3.2.2. World Cups 1-3 will be non-supported events by USAPM. USAPM does not intend to send a coach to these events. Athletes will be solely responsible for all requirements related to the World Cup while attending these events.

3.2.3. Senior World Championships is intended to be a USAPM supported event.

4. Communication of Selection Decisions

4.1. The PPC will meet and communicate to athletes a minimum of 30 days prior to World Cup 4 and the World Championships for selection to each rostered team.

8. Fitness to Participate

8.1 Selected athletes may be required to undergo an assessment (performance, physiological, medical, etc.) in the period between the selection date and the event if the PPC has reason to believe they are not fit to compete or no longer meet the aims of the process for the relevant competition, as set out in this document.
