### **IV. Transgender Athlete Policy**

The AAC will read through again and discuss this policy once everyone has had the time to review these policies.

#### V. Poomsae Pathways Review

- Freestyle 2x performance during the selection round
  - There were concerns that doing two performances doing the selection round of the team trials was too taxing on the freestyle athletes. This was addressed by the following changes:
    - If there are no people in the selection round, the top 4 in qualifying round will move on to selection round without having to compete in qualification round
    - Only one person (person who's coming in to the qualification round) will have to do it three times
- Concerns regarding referencing graphics:
  - C.Fu suggests that there should be a disclaimer: "for illustrative purposes only. Please refer to text for complete guidelines on pathways process."
- Taking more than 1 individual from the qualification round into selection round
  - D. Turgeon explains that USAT staff has pushed back heavily on this and we will stick with just 1 individual as opposed to top 4
- U17 wording causes a bit of confusion
  - D. Turgeon explains that this is to allow for the younger competitors of the 12-17 division to have an opportunity at team trials when the older and often qualified athletes leave the division
- What's the rationale for intl dominance # of competitors?
  - o D. Turgeon explains that 5 competitors is the WT standard
  - o For qualifying round, it's lower (1). Committee looked across all divisions to help make that determination. Many divisions in the older divisions will never have 5+ competitors and they didn't want to take away intl dominance from those athletes. This was kept this way in order to make the process more inclusive
