**1. SELECTION SYSTEM**

1.1. Provide the minimum eligibility requirements for an athlete to be considered for selection to the Team:

1.1.1. Nationality/Passport requirements:

Athlete must be a national of the United States at the time of nomination.

Athlete must hold a valid U.S. passport that will not expire for six months after the conclusion of the Games.

1.1.2. Minimum International Olympic Committee (IOC) standards for participation:

Any competitor in the Olympic Games must be a national of the country of the National Olympic Committee (NOC) which is entering such competitor. For additional information regarding an athlete who is a national of two or more countries, has changed his or her nationality or acquired a new nationality, refer to the Olympic Charter (Rule 41).

1.1.3. Minimum International Federation (IF) standards for participation (if any):

Athlete must be 18 years of age or older on or before December 31, 2024.

1.1.4. Other requirements (if any):

- Athlete must be a current Athlete member of USA Wrestling in good standing and be recorded in UWW's official database.
- Athletes must have successfully completed all Games Registration requirements by stated deadline.
- Any athlete age 18 or older will be required to undergo a background screen in accordance with the current [USOPC Background Check Policy](#).
- Any athlete age 18 or older as of the Closing Ceremony will be required to remain current with the U.S. Center for SafeSport's education and training requirements in accordance with the [USOPC Athlete Safety Policy](#).

Athletes qualify for the 2024 U.S. Olympic Trials – Wrestling through the following process.

NOTE: There is no requirement to have a certain number of athletes entered to compete within any given weight category at the 2024 U.S. Olympic Trials – Wrestling.

**a) Past USA World Championships or Olympic Games Participant or Final World or Olympic Team Trials Champion**

Any past Senior Freestyle World Championships participant and/or Final World or Olympic Team Trials Champion from 2018, 2019, 2020, 2021, 2022 or 2023 is automatically qualified to enter the 2024 U.S. Olympic Trials – Wrestling.

- b) 2023 U17 World Championships (August, 2023)**  
Any 2023 U17 Freestyle World Championships gold medalist is automatically qualified to enter the 2024 U.S. Olympic Trials – Wrestling
- c) 2023 U20 World Championships (August, 2023)**  
Any 2023 U20 Freestyle World Championships gold medalist is automatically qualified to enter the 2024 U.S. Olympic Trials – Wrestling
- d) 2023 Senior World Championships (September, 2023)**
- i. Any 2023 Senior World Championship Freestyle Medalist, at an Olympic weight, will earn an automatic berth into the final wrestle-off (i.e., Day Two) at the same weight they won a medal in the 2024 U.S. Olympic Trials – Wrestling.
  - ii. Any 2023 Senior World Championship Freestyle Medalist, at a non-Olympic weight, will earn an automatic berth into the semifinals (i.e., Day One) at a weight category immediately adjacent (one weight class up or down) from their 2023 Senior World Championship weight category.
- e) 2023 U23 World Championships (October, 2023)**  
Any 2023 U23 Freestyle USA World Championships gold medalist is automatically qualified to enter the 2024 U.S. Olympic Trials – Wrestling.
- f) 2023 Bill Farrell International Open (November, 2023)**  
The highest placed Senior Freestyle USA athlete per weight category, that places in the top 4, who has yet to qualify, will earn a spot in the 2024 U.S. Olympic Trials - Wrestling.
- g) 2023 U.S. Olympic Trials Qualifier (December, 2023)**  
The Senior Freestyle top 5 finishers per weight category at the 2023 USA Wrestling Olympic Trials Qualifier will earn a spot in the 2024 U.S. Olympic Trials – Wrestling.
- h) 2024 Pan American Championships (February, 2024)**  
Any Senior Freestyle Gold Medalist at the 2024 Pan American Championships will earn a spot in the 2024 U.S. Olympic Trials – Wrestling.
- i) 2024 Pan American Olympic Qualifier (March, 2024)**  
The Senior Freestyle USA athlete who qualifies the Olympic weight category at the Pan American Olympic Qualifier will earn a spot in the 2024 U.S. Olympic Trials – Wrestling.
- j) NCAA Division I Championships (March, 2024)**  
The 2024 NCAA Division I champion will earn a spot in the 2024 U.S. Olympic Trials – Wrestling at the weight category they choose.

**k) Final 2024 U.S. Olympic Trials Qualifier (March, 2024)**

The Freestyle champion of this event per weight category will qualify for the 2024 U.S. Olympic Trials – Wrestling. Athletes who have already qualified will NOT be allowed to compete in this event.

- 1.3. Provide a comprehensive, step-by-step description of the method that explains how athletes will go through the selection process.

The 2024 Olympic Team will be comprised of a maximum of six athletes – one athlete within each of the six Olympic weight categories (57kg, 65kg, 74kg, 86kg, 97kg, 125kg). The 2024 Olympic Team will be determined based on results at the 2024 U.S. Olympic Trials – Wrestling as described below. An athlete is only allowed to enter one weight category at the Olympic Trials.

NOTE: An athlete who has qualified to compete in the 2024 U.S. Olympic Trials – Wrestling through any of the methods outlined above may declare any weight category he chooses to compete in at trials regardless of the weight category in which he qualified. Each athlete must declare his weight category just prior to the scheduled weigh-ins at the 2024 U.S. Olympic Trials – Wrestling.

- Should any 2023 Senior World Championship medalist choose to compete at a different weight in which he medaled, he will NOT earn the automatic berth to the finals (Day Two) in the new weight category he enters.
- In this case, the athlete will compete in Day One of Trials.

**2024 U.S. Olympic Trials – Wrestling (April 19-20, 2024)**

Determining seeds for the 2024 U.S. Olympic Trials - Wrestling

The USA Wrestling National Team High Performance staff will determine the seeds for Trials.

- a. Seeding criteria for Trials will be published in the 2024 General U.S. Olympic Trials Procedures which will be posted on the USA Wrestling website a minimum of 60 days in advance of Trials.
- NOTE: A 2023 World Championship team member who qualifies the weight for the 2024 Olympics will automatically receive the #1 seed at the same weight category in which he qualified, with medalists earning an automatic berth to Day Two as explained below.

### Automatic berth to the semifinals

A 2023 Senior World Championship Olympic weight category medalist will receive an automatic berth to the 2024 U.S. Olympic Trials finals, at that respective weight (Day Two best of three series).

- If a 2023 Senior World Championship 97kg medalist moves to 125kg, that individual will receive an automatic berth to the semifinals of Olympic Team Trials Tournament (Day One).
- If a 2023 Senior World Championship 125kg medalist moves to 97kg, that individual will receive an automatic berth to the semifinals of Olympic Team Trials Tournament (Day One).

NOTE: The above two weight categories (97kg & 125kg) are specifically noted because the two weight categories are immediately adjacent to World weight categories.

A 2023 Senior World Championship non-Olympic weight category medalist will receive an automatic berth to the semifinals of Olympic Team Trials Tournament (Day One).

- A 2023 Senior World Championship non-Olympic weight category medalist may only move one World weight category up or down immediately adjacent to their 2023 World Championships weight in order to receive the automatic berth to the semifinals of the Olympic Team Trials Tournament.
- If a 2023 Senior World Championship non-Olympic weight category medalist moves more than one World weight category, he will not receive an automatic berth to the semifinals.

#### **A. Weight category with a 2023 World Championship medalist**

##### **1. Day One (Olympic Team Trials Tournament)**

Day One will determine who will wrestle the 2023 World Championship Olympic weight medalist (the 2023 World Championship Olympic weight medalist earns a bye-out of Day One, provided he is competing in the same Olympic weight category in which he won his World Championship medal). The finals of Day One will be a single match. (For information regarding a delay to Day Two, see below.) All best of three matches will occur on Day Two of the Olympic Trials.

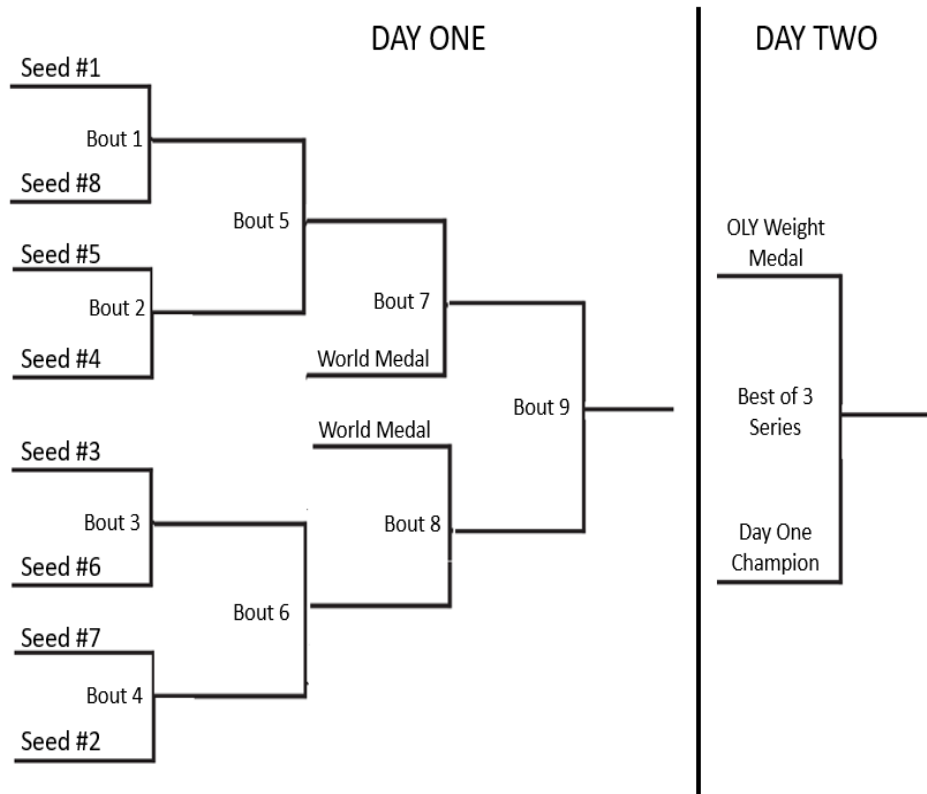
##### **2. Day Two (best of 3 match final wrestle-off)**

The winner of Day One will face the 2023 World Championship Olympic weight medalist in a best of three matches.

Day One and Day Two of the 2024 U.S. Olympic Trials – Wrestling will be held over two days, except when a request for delay is granted for Day Two. The winner of Day Two shall be USA Wrestling’s designee for the Olympic Games.

- If an athlete is unable to compete in Day Two of the 2024 U.S. Olympic Trials, his opponent will be declared the winner of Day Two and will be USA Wrestling’s designee for the 2024 Olympic Games unless a request for delay due to injury has been granted. (For information regarding a delay to Day Two, see below.)

### Request for Delay Due to Injury

- Only a 2023 World Championship Olympic weight medalist, who earned an automatic berth into the final wrestle-off, can request a delay for competing in Day Two for medical reasons at least 48 hours prior to the scheduled weigh-in time (no request for delay will be allowed, or granted, with less than 48 hours before weigh-in).
- The request must be submitted in writing to the Freestyle Sport Committee Chair for review, to include a written certification of the injury from a USA Wrestling-approved medical doctor. USA Wrestling's approval of a medical doctor will not be unreasonably withheld.
- If a certified medical doctor's note is provided within the appropriate timeframe to support a 2023 World Championship Olympic weight medalist's request for a delay, the request for a delay in competition will be granted.
- If a delay is granted, the Freestyle National Coach with the two athletes involved shall determine the date for conducting Day Two of the 2024 U.S. Olympic Trials – Wrestling. If an agreement cannot be reached by the two athletes involved, then the Freestyle Sport Committee will determine the date and place. The wrestle-off, or Day Two, must be held prior to the sport entry deadline of June 7, 2024.
- If a delay is granted for Day Two and the 2023 World Championship Olympic weight medalist is unable to compete for any reason prior to the sport entry date of June 7, 2024, the winner of Day One shall be declared the winner of Day Two and will be USA Wrestling's designee for the 2024 Olympic Games.
- If a delay is granted and the winner of Day One is unable to compete in Day Two for any reason prior to the sport entry date of June 7, 2024, the 2023 World Championship Olympic weight medalist shall be declared the winner of Day Two and will be USA Wrestling's designee for the 2024 Olympic Games.

#### **B. Weight category does not have a 2023 World Championship medalist**

##### **1. Day One (Olympic Team Trials Tournament)**

Day One will determine who will wrestle in the final on Day Two. The finalists of Day One will compete in a best of three series on Day Two to determine who will be USA Wrestling's designee for the 2024 Olympic Games.

## 2. Day Two (best of 3 match final wrestle-off)

The winner of the best of three series will be nominated to the Games.

- If an athlete is unable to compete in the best of three series, his opponent will be declared the winner of Day Two and will be USA Wrestling's designee for the 2024 Olympic Games.

## C. Weight categories are not qualified into the 2024 Olympic Games prior to the 2024 U.S. Olympic Trials – Wrestling

All Olympic weight categories will be contested at the 2024 U.S. Olympic Trials – Wrestling, regardless of whether the weight category has qualified into the 2024 Olympic Games. If the weight category has not qualified for the Games, USA Wrestling would have to qualify the weight category at the following World Olympic Games qualifying tournament.

- **World Olympic Games qualifying tournament (May 2024 @ Istanbul, Turkiye)**
  - The winner of the 2024 U.S. Olympic Trials - Wrestling will compete at the World Olympic Games qualifying tournament.
    - If for any reason the U.S. Olympic Trials winner is unable to compete in this tournament, a replacement will be determined in accordance with Section 4.1.1.
  - If the weight category is qualified via the World Olympic Games qualifying tournament, the winner of the 2024 U.S. Olympic Trials – Wrestling will be USA Wrestling's designee for the 2024 Olympics, regardless of who qualifies the weight category at the qualifying tournament.
    - If for any reason the U.S. Olympic Trials winner is unable to compete at the 2024 Olympic Games, a replacement will be determined in accordance with Section 4.1.1.

2.3.1 Specify the process that will be used to identify and handle any potential conflicts of interest involving a member of the committee.

All members of the selection committee must comply with the NGB's conflict of interest policy, to include completing and submitting a disclosure form for review by the NGB's ethics committee prior to convening the committee.

Any member of the selection committee who has an actual, possible, or perceived conflict of interest must disclose it to the NGB's ethics committee prior to the start of the selection process and/or recuse him/herself from the review process and/or voting. A conflict of interest exists when a personal, family, financial, professional, club, team or business interest of the committee member poses a direct or indirect relationship, connection, or affiliation, past or present, with an athlete in contention for the applicable team selection that could compromise the committee member's ability to participate in the selection process in an unbiased manner. If a conflict exists, the NGB's ethics committee shall review the conflict and determine the committee member's level of involvement (e.g., whether that committee member must recuse him/herself from participating in discussions and/or voting). For example, if it is determined that a committee member must recuse him/herself from voting, the ethics committee may still determine that a committee member who has relevant and necessary information with respect to athlete performance, for example a national team coach or high performance director, may, if requested by the selection committee, provide such information to the committee so long as such information is provided in a fair and unbiased manner and so long as the committee member with the conflict of interest does not vote toward the final decision. The committee member must not otherwise influence other members of the committee in the selection process.

Additionally, any person (including any potentially impacted athlete or coach of a potentially impacted athlete) with a good faith belief that a committee member has a conflict of interest may report the alleged conflict of interest to NGB's ethics committee. Reports may be made anonymously. No committee member shall retaliate in any way against a person who, in good faith, reports an alleged conflict of interest.

Any recused individual shall be replaced in accordance with the NGB selection committee appointment process.

### **3 REMOVAL OF ATHLETES**

3.1 Prior to submitting athlete entries by name to the USOPC, USA Wrestling has jurisdiction over potential nominees.

An athlete who is to be nominated to the Team by USA Wrestling may be removed for any of the following reasons, as determined by USA Wrestling:

- 3.1.1 Voluntary withdrawal. Athlete must submit a written letter to the USA Wrestling CEO/Executive Director.
- 3.1.2 Injury or illness as certified by a physician (or medical staff) approved by USA Wrestling. If an athlete refuses verification of his/her illness or injury by a physician (or medical staff) approved by USA Wrestling, his/her injury will be assumed to be disabling and he/she may be removed.
- 3.1.3 Failure to participate in Mandatory Training and/or Competition as defined in Section 9 of these procedures.
- 3.1.4 Violation of USA Wrestling's Code of Conduct (<https://www.teamusa.org/usa-wrestling/membership/usa-wrestling-policies>).
- 3.1.5 Non-compliance with the eligibility requirements listed in Section 1.1. of these selection procedures.
- 3.1.6 Failure to follow the weight control plan as mutually agreed upon by the athlete, National Coach and medical professional (see Section 9).

An athlete who is removed from the Team pursuant to this provision has the right to a hearing per USA Wrestling's Bylaws: <https://content.themat.com/forms/Bylaws.pdf> and the USOPC's Bylaws, Section 9.

3.2 Once athlete entries have been submitted by the USOPC to the Local Organizing Committee, the USOPC has jurisdiction over the Team, at which time, in addition to any applicable NGB Code of Conduct, the USOPC's Delegation Conduct Requirements apply, contained in the USOPC Games Delegation Terms. The USOPC Games Delegation Terms are specific to each Games and made available during the Games registration process; the USOPC's Grievance Procedures and Hearing Process are found within the Delegation Terms. 3.3 An athlete may be removed as a nominee to the Team or from the Team for an adjudicated violation of IOC, WADA, IF, USADA and/or USOPC anti-doping protocol, policies, and procedures, as well as the U.S. Center for SafeSport Code, the USOPC Athlete Safety Policy and USA Wrestling's SafeSport policies, as applicable.

#### 4. REPLACEMENT OF ATHLETES

4.1 Describe the selection and approval process for determining replacement athlete(s) should a vacancy occur:

4.1.1 prior to submission of Entries by Name to the Local Organizing Committee, including any applicable group or committee:

**Weight category is qualified for the Olympic Games prior to the 2024 U.S. Olympic Trials – Wrestling**

If for any reason a replacement athlete is needed, the next ranked athlete from Trials at the weight category in question will be selected, up to and including the fourth-ranked athlete, from the 2024 U.S. Olympic Trials – Wrestling provided the replacement is substantially completing the requirements of the Olympic Team Training Camp (see Section 9 below) as determined by the National Coach. Athletes will receive the Olympic Team Training Camp requirements via email at least 60 days in advance of the Camp.

**Weight category is not qualified into the Olympic Games prior to the 2024 U.S. Olympic Trials – Wrestling**

If for any reason a replacement athlete is needed for the World Olympic Games qualifying tournament(s) in May 2024 (see Section 1.3.), the next ranked athlete from Trials at the weight category in question will be selected, up to and including the fourth-ranked athlete, from the 2024 U.S. Olympic Trials – Wrestling provided the replacement is substantially completing the requirements of the Olympic Team Training Camp (see Section 9) as determined by the National Coach. Athletes will receive the Olympic Team Training Camp requirements via email at least 60 days in advance of the Camp.

4.1.2 after submission of Entries by Name to the Local Organizing Committee, including any applicable group or committee:

4.2 All replacement athletes must meet all requirements listed in Section 1.1.

#### 5. SUPPORTING DOCUMENTS

USA Wrestling will retain the approved Selection Procedures and all supporting documents, including scouting or evaluation forms, etc., and data from the selection process for six months past the date of the Closing Ceremony of the Games.

## 6. REQUIRED DOCUMENTS

In addition to the USOPC Code of Conduct, the following documents are required to be signed by an athlete as a condition of nomination to the Olympic Games and are included as attachments:

## 7. PUBLICITY/DISTRIBUTION OF PROCEDURES

## 8. DATE OF NOMINATION

The Nomination of Athletes form, including replacements, will be announced to all athletes and submitted to the USOPC on or before:

June 7, 2024

## 9. MANDATORY TRAINING AND/OR COMPETITION

Specify the location, schedule, and duration of mandatory training and/or competition:

Athletes nominated to the Team will be required to attend and participate in the Olympic Team Training Camp.

The location, schedule, and duration of the Olympic Team Training Camp will be determined by the Freestyle National Coach. The training camp schedule will be confirmed and posted on the USA Wrestling website (<https://www.teamusa.org/USA-Wrestling>) at least sixty (60) days in advance of the training camp.

While waivers for mandatory training will not be unreasonably withheld, all athletes nominated to the Team should arrange for appropriate time off from school, work, or other obligations in advance of the training camp. Waivers will primarily be granted for injury or

other similar incapacity or for a personal/family emergency. Requests for a waiver must be submitted in writing to the Freestyle National Coach as far in advance as possible.

If needed, a weight control plan as mutually agreed upon by the athlete, National Coach and medical professional may be put in place in an effort to maximize athlete safety and performance. Failure to follow the weight control plan may be grounds for removal from the Team.

#### **10. ANTI-DOPING REQUIREMENTS**

Athletes must adhere to all IOC, WADA, IF, USADA and USOPC anti-doping protocols, policies, and procedures, as applicable. This includes participation in Out-of-Competition Testing as required by the IOC, WADA, IF, USADA and USOPC Rules, as applicable.

If any force of nature, or force majeure, should cause the alteration or cancellation of any of the selection events listed in this document, these selection procedures will be revised, pursuant to their resubmission to the USOPC.

The Athlete Ombuds Office provides cost-free, independent, and confidential advice regarding athlete rights, grievance procedures and any other related guidance pertaining to selection procedures and can assist in mediating disputes between athletes and their NGB/PSO.
