Contest Rules: IJF current contest rules will apply with the following exceptions:

All matches will be 4 minutes. Competition will be either Modified Double Elimination or Round Robin or Kohaku depending on the number of competitors in the division.

Competition areas will be 8 meters by 8 meters. Safety zones will be 3 meters around the outside edges and 4 meters between adjoining mats.

No Arm Bars allowed in any Novice Division and under the age of the 15.

Injured players who do not finish a match or are withdrawn may not return to compete in any capacity.

The tournament director reserves the right to add, delete and/or modify any division for safety of competitors.

No Awards will be given. The Matches are being fought solely for experience and bragging rights!
