

**Season Ticket Member Skate – Second Half of Season Poll Sweepstakes
(The “Sweepstakes”)**

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID WHERE PROHIBITED BY LAW. BY ENTERING, EACH ENTRANT ACCEPTS AND AGREES TO BE BOUND BY THESE OFFICIAL RULES. EXCEPT WHERE PROHIBITED BY LAW, ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

ELIGIBILITY: The Sweepstakes is open only to legal residents of the United States (the “**Eligible Territory**”) who are eighteen (18) years of age (except in the case of residents of jurisdictions where the legal age of majority is greater than eighteen (18) years, such legal age of majority) or older at the time of entry. Employees, officers, and directors, and their immediate family members (spouse, parent, child, sibling, and their respective spouses, regardless of where they reside) and members of the same household (whether or not related), of PWHL LeagueCo US LP (“**PWHL**”) and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any other entity associated with the Sweepstakes are not eligible to participate or win the prize. The Sweepstakes is subject to all applicable laws, rules, and regulations. Void outside the Eligible Territory and where prohibited or restricted by law, rule, or regulation.

HOW TO ENTER: The Sweepstakes entry period begins at 5:00 PM Central Time (“**CT**”) on February 26, 2026 and ends at 8:30 PM CT on February 26, 2026 (“**Entry Period**”). On February 26, 2026, PWHL staff will be at the Season Ticket Member Skate Event at the Roseville Skating Center & John Rose MN Oval (the “**Location**”). During the Entry Period, attendees at the Location may enter the Sweepstakes by scanning a QR Code at the Location, and providing their name, email address, phone number and postal code. In order to enter the Sweepstakes, all entrants must have a valid email address, which must be used on the Sweepstakes landing page to enter the Sweepstakes. No other method of entry will be accepted. Upon submission of the required information, entrants will receive access to a poll questionnaire.

No other method of entry will be accepted. All entries must be complete and legible in order to qualify, and will be void if they are, in whole or in part, incomplete, illegible, damaged, irregular, counterfeit, altered, or obtained through theft or fraud. Limit one (1) entry per person, household address, email address or IP address. Additional entries beyond the specified limit will be void. All entries will be considered made by the authorized account holder of the email address. Use of any automated entry software is prohibited. PWHL is not responsible for lost, late, illegible, misdirected or mutilated entries, including due to technical/network failures, human error, or any other error or malfunction.

WINNER DETERMINATION AND ODDS OF WINNING: Twenty-five (25) participants who submit answers to the poll questionnaire will be randomly selected to receive a prize. All decisions made by PWHL are final and binding. Subject to verification of eligibility and compliance with these Official Rules, potential winners will be declared the winners of the Sweepstakes. Odds of winning depend on the total number of eligible entries received.

PRIZE: UP TO TWENTY-FIVE (25) PRIZES WILL BE AWARDED. The first winner to be randomly selected will receive a Minnesota Frost Jersey, signed by members of the Frost team, with an approximate retail value (“**ARV**”) of \$150. Subsequent winners shall receive their choice between: a stocking cap (ARV \$30; 5 available); a rally towel (ARV \$3; 7 available); a replica banner (ARV \$15; 5 available); or a bucket hat (ARV \$10; 7 available). Prize selection is subject to availability.

PRIZE CONDITIONS: All prize details shall be determined in the sole and absolute discretion of PWHL. Each winner is fully responsible for any and all applicable taxes (including income and withholding taxes). All costs and expenses associated with prize acceptance and use which are not specifically included in the prize description above, including, but not limited to, transportation, lodging, meals, and other expenses, are the sole responsibility of the winner. The prize is non-transferable and non-assignable, with no cash redemptions. No substitution by the winner is permitted. No refund or other monetary or non-monetary consideration shall be provided to winners. PWHL reserves the right to substitute the prize (or any portion thereof) with a prize of comparable or greater value at its sole and absolute discretion.

NOTIFICATION: Each potential winner will be announced over the public address system at the Location and/or notified at the email address provided at the time of entry (the “**Prize Notification**”). In the event that any potential winner does not respond to the Prize Notification within forty-eight (48) hours of receipt of Prize Notification, or declines the prize for any reason, a disqualification will result, the prize will be forfeited and, at PWHL’s sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible entries. Failure to submit any identification required by PWHL within the specified time period, noncompliance with these Official Rules, the return of the Prize Notification or of the prize (or any portion thereof) as non-deliverable may result in the potential winner’s disqualification and prize forfeiture and, at PWHL’s sole discretion and time permitting, may cause an alternate potential winner to be randomly selected from among all remaining eligible entries.

GENERAL CONDITIONS: The decisions of PWHL are final and binding on all matters relating to this Sweepstakes. Released Parties are not responsible for stolen, late, incomplete, illegible, inaccurate, misdirected, lost, misrouted, scrambled, damaged, delayed, undelivered, mutilated, or garbled entries, transmissions, email, or mail; lost, interrupted, or unavailable network, cable, satellite, server, Internet Service Provider (ISP), wireless network, website, or other connections; availability, accessibility, miscommunications, or failures of computer, satellite, telephone, cable, or wireless transmissions or lines; computer hardware or software malfunctions, failures, or difficulties; wireless service congestion; failures or malfunctions of phones, phone lines, telephone systems, wireless towers, or cellular tower equipment; any error, omission, interruption, defect, or delay in wireless or other transmission, processing, or communication; printing, typographical, or other errors appearing within these Official Rules, in any Sweepstakes-related advertisements, or other materials; or any other errors, problems, or difficulties of any kind, whether human, mechanical, electronic, or other, relating to the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with administration of the Sweepstakes, processing of entries, announcement of the winner, or any Sweepstakes-related materials. Entries generated by a script, macro, or other mechanical or automated means will be disqualified. In the event of dispute as to the identity or eligibility of any potential winner based on an email address, the winning entry will be declared made by the Authorized Account Holder of the email address used to enter the Sweepstakes, provided he/she is eligible according to these Official Rules. The "**Authorized Account Holder**" is defined as the natural person to whom the applicable ISP or other organization (such as a business or educational institution) has assigned the submitted email address for the domain associated with such email address.

ARBITRATION; CLASS ACTION WAIVER: EXCEPT WHERE PROHIBITED BY LAW, as a condition of entering this Sweepstakes, each entrant agrees that (a) any and all disputes, claims, controversies, or causes of action arising out of or relating to this Sweepstakes or any prizes awarded (each, a "**Claim**") shall be (i) arbitrated on an individual basis only and shall not be consolidated or joined with or in any arbitration or other proceeding involving a Claim of any other party and (ii) settled by binding arbitration in New York County, New York before a single arbitrator appointed by JAMS in accordance with its then governing rules and procedures, and judgment on the award rendered by the arbitrator may be entered by any court having jurisdiction thereof; and (b) under no circumstance will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, consequential, or any other damages, other than for actual out-of-pocket expenses. For residents of certain states or provinces, the limitations set forth above may be inapplicable where attorneys' fees, court costs, or other damages are mandated by statute. EXCEPT WHERE PROHIBITED BY LAW, these Official Rules shall be governed by and construed and interpreted in accordance with the laws of the State of New York, U.S.A, applicable to contracts entered into and performed exclusively in that State.
