E-Learning Subcommittee

Term commitment: 3 years

(Term commitment for Fellow in Training Representative: 1 year)

Charge: The E-Learning Subcommittee shall concern itself with overseeing the quality, creation and implementation of enduring materials* related to the Committee on Training charge with the purpose of identifying synergies, avoiding duplication, identifying trends, and evaluating metrics. - Approximately 3-4 virtual calls ~2 hours in duration per volunteer year to address specific programs/projects

- Available to serve one consecutive three-year term on the Subcommittee
- *(The Fellow in Training Representative must be an active ACR Transitional member and only serves a one-year term on the Subcommittee)*

Educator Resources Subcommittee

Term commitment: 3 years

(Term commitment for Fellow in Training Representative: 1 year)

Charge: The Educator Resource Subcommittee shall concern itself with maintaining core curriculum content, identifying curricular gaps and resources to fill those gaps, identifying resources for educators to obtain teaching tools, and maintaining a platform for educators to showcase their work. Pediatric Training Subcommittee

Term commitment: 3 years

Charge: The Pediatric Training Subcommittee shall concern itself with addressing the needs of pediatric rheumatology training program directors, faculty, educational scholars, and pediatric rheumatology trainees by hosting Pediatric Program Director Business Meetings, providing updates to the Pediatric Program Directors, and serving as liaisons to other ACR pediatric groups. Member commitment:

- Approximately 8 virtual calls ~1 1/2 hours in duration per volunteer year to address specific programs/projects
- 2-10 hours spent on outside work prior to each meeting, depending on committee assignments

Eligibility Requirements:

- An ACR Transitional member in good standing
 - **Adult Rheumatology Fellow-in-Training Nominees**
 - Fellows enrolled in a two-year adult training program must be in their first year of fellowship to apply and sit on the subcommittee.
 - Fellows enrolled in a three-year adult training program can be in their first or second year of fellowship to apply and sit on the subcommittee.
 - **Pediatric Fellow-in-Training Nominees**
 - Fellows enrolled in a three-year pediatric training program can be in their first or second year of fellowship to apply and sit on the subcommittee.
- Available to serve one consecutive two-year term on the Subcommittee
 - Actively enrolled in an ACGME accredited or Royal College of Physicians and Surgeons of Canada (RCPSC) rheumatology training program during the duration of the two-year term.
