ENVIRONMENTAL PROTECTION COMMISSION CHAPTER 1-6 SERVICES - FEE SCHEDULE RULE

AN ACT AMENDING CHAPTER 1-6 OF THE RULES OF THE ENVIRONMENTAL PROTECTION COMMISSION RELATING TO FEES CHARGED BY THE COMMISSION IN REVIEWING PERMITS AND PROVIDING SERVICES TO THE COUNTY; SEPARATING OUT OF EXISTING AIR, SOLID WASTE, AND WATER OPERATION FEES THE COST OF REVIEWING PERMITS FROM THE COST OF COMPLIANCE INSPECTIONS OVER THE TERM OF THE PERMIT; AMENDING FEES FOR CERTAIN AIR, SOLID WASTE, AND WATER PERMITS; ADDING FEES FOR MINOR PERMIT MODIFICATIONS, RESIDUAL SITE APPLICATION APPROVALS, AND CERTAIN GENERAL PERMITS; CLARIFYING FEE WAIVER PROVISIONS; REQUIRING PAYMENT OF FEES FOR SERVICES PRIOR TO PERMIT REVIEW; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Environmental Protection Commission of Hillsborough County is empowered by Chapter 84-446, laws of Florida to adopt and amend from time to time rules to provide for appropriate fees to be charged for services rendered under the provisions of the Act, and

WHEREAS, the Commission determines that it is reasonably necessary for the effective implementation of Chapter 84-446, Laws of Florida to amend and clarify its rule providing fees to be charged for its services, and

WHEREAS, the Commission published due notice of its intent to consider adoption of amendments to its Fee Schedule Rule, Chapter 1-6, in Hillsborough County,

NOW, **THEREFORE**, the Environmental Protection Commission of Hillsborough County, in regular public meeting this <u>25th</u> day <u>September</u>, 1991, enacts the following:

<u>Section 1</u>. A rule amending Chapter 1-6, Rules of the Environmental Protection Commission, is adopted to read:

<u>Section 2</u>. It is declared to be the intent of the Environmental Protection Commission tat the provisions of this rule be severable. If one or more of the sections, subsection, sentences, clauses or provisions are held invalid, for whatever reason, the remaining portions shall not be affected.

Section 3. This rule shall be effective upon approval in accordance with law.

1-6.01 DECLARATION AND INTENT

Said charges are for the purpose of defraying expenses incurred by the Environmental Protection Commission in performing professional services necessitated by the actions of others. All funds collected for said services shall become funds of Hillsborough County and shall be deposited in the General Revenue Fund.

1-6.07 FEE WAIVERS

- 1. Executive Director may waive the appropriate application fee in cases of financial hardship.
- 2. The Executive Director may modify or waive an application fee in circumstances where unfairness would otherwise be the result.

1-6.08 PROHIBITIONS

The fees listed in Sections 1-6.02 through 1-6.05 are due and payable upon submission of a request, application or notification. Whenever a request, application or notification is submitted without the required fee, receipt shall be acknowledged and the request, application or notification shall be immediately returned with attachments; no further action shall be taken until the appropriate fees are submitted along with the supporting documents. It shall be a violation to fail to pay a required fee.
