Actions Taken

Administrative actions that have occurred to address the opioid crisis


- In 2010, Hillsborough Board of County Commission (BOCC) enacted an ordinance to eliminate pill mills;
- Eliminated Coverage of Chronic Pain Management at the primary care level for Hillsborough County Health Care Plan in coordination with the PCP's;
- Funding for 12 Initial Secured Treatment Beds and Behavioral Health Jail Diversion Program;
- Co-located Behavioral and Primary Care Pilot Program for Hillsborough County Health Care Plan Participants;



Actions Taken

Administrative actions that have occurred to address the opioid crisis

- Criminal Justice Liaison and enhancements through Mental Health Court;
- Integration of Social Determinants such as Housing, Food, Transportation for Behavioral Health;
- Establishment of Intermediary Beds (60-120 Days);
- In September 2017, Hillsborough County held the first Opioid Summit;
- In 2018, Hillsborough County announced a lawsuit against opioid manufacturers, distributors, and other viable parties; and
- In September 2018, the BOCC approved Phase I of the County's Opioid Action Plan;
- \$1.4M (Hillsborough County's allocation) received thus far in opioid settlement funds. Additional funds anticipated in the future.



Projects

Current projects underway to assist which serve to create a continuum of care services for residents requiring substance abuse and behavioral health treatment include:

- Additional twenty (20) Intermediary Beds to local treatment providers;
- Pending legislative funding allocation for the continuance of twelve (12) Short Term Residential Treatment Beds;
- Funding approved for Orient Rd Step Down facility from American Rescue Act Funds;
 - Additional funding to support Orient Rd project from CFBHN for case managers to coordinate warm handoff for wraparound services;


Projects

Current projects underway to assist which serve to create a continuum of care services for residents requiring substance abuse and behavioral health treatment include:

- Development of Psychosocial Rehabilitation/ Clubhouse by ACTS with funding support from BayCare, Central Florida Behavioral Health (CFBHN), Hillsborough County, and other partners;
- Planned increases in substance abuse funding utilizing opioid settlement dollars as identified by the HCAB Behavioral Health Task Force (BHTF);
- Health care services funding for in-house Jail Case
 Managers for HCHCP members; and
- Implementation of Social Determinants of Health for HCHCP members.



Funding over the last 9 years



Funding from Hillsborough County and from DCF/CFBHN has typically increased each year over the past 9 years.

These actions help to indicate a continued level of support for citizens with issues related behavioral health and/or substance abuse.

 - Prevention, education, treatment, & recovery
 - BHTF to discuss and recommend actions to the BOCC
 - BHTF to identify funding sources
 - Continue to implement opioid and substance abuse action plan
