



# Right-Of-Way Permit Fee Schedule

Fees are required to supplement the costs associated with reviewing and processing Right of Way Use Permit applications and the inspection of work performed. Fees for right of way use permits are set by the Hillsborough County Board of County Commissioners and shall be paid by the permittee upon submission and approval of the ROW Use Permit application. Checks, money orders, cash, or other acceptable forms of payment will be made payable to the Hillsborough County Board of County Commissioners for the exact fee amount.

<b>BASE APPLICATION FEE</b>	
The base application fee is intended to supplement the county's cost associated with the clerical, administrative, and engineering cost to process each permit, regardless of the permit application's approval or disapproval. <ul style="list-style-type: none"> <li>All permit application requests require a \$50 base fee.</li> </ul>	\$50
<b>Access (Driveway) Application Fees</b> (in addition to the base fee)

<b>Access Type I Residential:</b> Average daily traffic < 50 vehicles	\$50
<b>Access Type II Commercial:</b> 50 < Average daily traffic < 1,500 vehicles	\$75
<b>Access Type III Commercial:</b> Average daily traffic > 1,500 vehicles	\$125
<b>ROW Application Fees</b> (in addition to the base fee)	
<b>No Roadway Crossings</b> <ul style="list-style-type: none"> <li>Open trench or trenchless work parallel to roadway</li> </ul>	\$150
<b>Open Trench Roadway Encroachment or Crossing</b> <ul style="list-style-type: none"> <li>Digging open trench in, across, or encroaching on road</li> </ul>	\$250
<b>Trenchless Roadway Crossing ≤ 2" ∅</b> <ul style="list-style-type: none"> <li>Crossing road, no open trench in road, boring under ROW with pipe or conduit ≤ 2" ∅</li> </ul>	\$100
<b>Trenchless Roadway Crossing &gt; 2" ∅</b> <ul style="list-style-type: none"> <li>Crossing road, no open trench in road, boring under ROW with pipe/conduit &gt; 2" ∅</li> </ul>	\$200
<b>Open Trench Construction Fee</b> <ul style="list-style-type: none"> <li>Open trench work parallel to roadway</li> <li>For excavations exceeding 10 linear feet</li> <li>Not to exceed \$500</li> </ul>	\$1 per linear foot
<b>Supplemental large facility project (SFLP)</b> <ul style="list-style-type: none"> <li>Structure &gt; 75' high or pole &gt; 24" ∅</li> </ul>	\$1,000
<b>SPECIALTY FEES</b>	
<b>Special Activity Fee</b> - (in addition to the base fee) <ul style="list-style-type: none"> <li>Certain special activities which require full time inspections during the course of the activity (directional drilling, jack and bore under major roadways, bodies of water, structures, etc.)</li> </ul>	\$300 per permit
<b>Re-Inspection Fees</b> - (For projects requiring re-inspections in excess of the 5 allotted) <ul style="list-style-type: none"> <li>1st re-inspection</li> <li>2nd re-inspection</li> <li>3rd re-inspection</li> <li>Each additional re-inspection</li> </ul>	\$150 \$300 \$600 \$900
<b>Annual General Use Permit</b>	Per square mile of service area Maximum fee \$27.50 \$25,000
