CII's divisions of each of the investment management entities collectively provide investment management services under the name "Capital International Investors." CII is deemed to be the beneficial owner of 31,642,100 shares or 10.1% of the 314,264,726 shares believed to be outstanding. Shares reported include 1,522,681 Convertible Preferred Stocks, which represent 152,268 Common Stock.
